INVITATION TO BID FOR SEPTAGE COLLECTION, HAULING, TREATMENT AND DISPOSAL SERVICES

- 1) The **HERMOSA WATER DISTRICT**, through the **Approved Corporate Operating Budget for CY2025** intends to apply the sum of **Four Million Twenty Thousand Pesos (P 4,020,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Septage Collection, Hauling, Treatment and Disposal Services**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The **HERMOSA WATER DISTRICT** now invites bids for **Septage Collection, Hauling, Treatment and Disposal Services** using the **single year Framework Agreement**. Delivery of the Goods is required **within One (1) month from the date of issuance of each Call-Off**. Bidders should have completed, at least **within the last 5 years** from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4) Interested Bidders may obtain further information from **HERMOSA WATER DISTRICT** and inspect the Bidding Documents at the address given below from **8:00AM to 5:00PM (Monday to Friday, except during holidays)**.
- 5) A complete set of Bidding Documents may be acquired by interested Bidders on **October 22, 2025** from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines by the GPPB, in the amount of **Four Thousand Pesos Only (P 4, 000.00)**.

[Note: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of Hermosa Water District, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The **HERMOSA WATER DISTRICT** will hold a Pre-Bid Conference on **October 30, 2025, 2pm** at **HWD Conference Room, HWD Building, Magsaysay St., Brgy. Sto. Cristo, Hermosa, Bataan**, which shall be open to prospective Bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before **10:00AM of November 17, 2025**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) Bid opening shall be on **November 17, 2025 at 10:01AM** at **HWD Conference Room, HWD Building, Magsaysay St., Brgy. Sto. Cristo, Hermosa, Bataan**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) *Only bidders who have submitted proof of payment of bidding documents will be allowed to submit their bids. Representatives of bidders shall be duly authorized in writing.*
- 11) The **HERMOSA WATER DISTRICT** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70¹ of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
