Criticized for lacking clear mechanisms for implementation and being an informal arrangement without binding treaties. But still seen as an influential forum for major economies. 2022 G20 Summit was held in Bali, Indonesia with India slated to host the next G20 Summit in 2023 in New Delhi. G20 Summit serves as a key international forum for cooperation and policy coordination between leading advanced and emerging economies across some of the most pressing global issues.
