



- Educating women helps prevent child marriage because: More access to education for women will help reduce the likelihood of child marriage.





- Article 16: All people should have equal access to possibilities for public posts.
- ❖ Article 39(d): Fair pay for equal labour for men and women.
- Article 42: The state shall provide for the first and humane conditions of employment and maternity leave.

Also, the government has passed particular legislation to advance the position of women and protect their rights. Which are:

- **The Hindu Succession Act, 1956** which provides for women the right to parental property.
- **❖ The Dowry Prohibition Act of 1961,** which forbids the taking of dowries and thereby protects women from exploitation.
- **Equal Remuneration Act, 1976** which provides payment of remuneration equal with men forwork of equal value.
- * The Medical Termination of Pregnancy Act, 1971 which legalizes abortion conceding the right of a women to go for abortion on the ground of physical and mental health.
- ❖ The Criminal Law Amendment Act of 1983, which aims to eradicate several kinds of offences committed against women.
- ❖ The Indecent Representation of Women (Prohibition) Act of 1986 forbids the vulgar portrayal of women in the media, including movies, television, and newspapers.
- ❖ The Protection of Women from Domestic Violence Act of 2005 aims to more effectively safeguard the rights of women who experience abuse of any sort inside the family and who are protected by the Constitution.

The National Policy for the Empowerment of Women, 2001 seeks to advance, develop, and amplify women's voices. According to the policy, "Equal access to education would be provided for women and girls. Special steps will be taken to end discrimination, universalize education, end illiteracy, create gender-sensitive educational systems, increase girls' enrollment and retention rates, and improve the quality of education to support women's development of technical or vocational skills as well as lifelong learning.
