Abstract:

The Indian Society is not as simple as it looks from the outside. India includes a sizable amount of tribal folks that still belong to a social set-up, of which little or nothing is understood. These tribes who stay in several parts of the country are still to return out of their traditional way of life and join the mainstream. As per the 2011 census, India contains 705 scheduled tribes (STs) and subtribes and 75 primitive tribal clusters. This study explores tourists' perceptions of tribal tourism destinations in India, with a focus on their experiences, feedback, and awareness of sustainable tourism practices. The survey reveals that visitors are drawn to the region's rich tribal culture, traditions, and natural landscapes. INTRODUCTION:

The word "Tribe" is taken from the Latin word "Tribus" which means "one third". The word originally referred to one of the three territorial groups which united to make Rome. India is known as a Melting pot of tribes and races. After Africa India has the second largest concentration of tribal population within the world. In India aboriginal tribes have lived for 1000 of years in forests and hilly areas without any communication with various centers of civilization. Now, there is a need to integrate tribes in to main stream of the society as a rightful member with respect.

Definition of Tribal:

According to the Imperial Gazetteer of India, a tribe is a collection of families bearing a common name, speaking a common dialect, occupying or professing to occupy a common territory and is not usually endogamous, though originally it might have been so.

As per the definition of **Oxford Dictionary** "A tribe is a group of people in a primitive or barbarous stage of development acknowledging the authority of a chief and usually regarding themselves as having a common ancestor".

Lucy Mair defines Tribe as "an independent political division of a population with a common culture". While D.N. Majumdar defines tribe as "a social group with territorial affiliation, endogamous with no specialization of functions ruled by tribal officers hereditary or otherwise, united in language or dialect recognizing social distance with other tribes or castes".

Tribe has been the most salient category used in the study of Indian indigenous ethnic formations: the adivasi societies. It is my contention that the tribal construct in India is a colonial category and that it formed part of the colonial legitimizing ideology. As such this category operated as a device to catalogue conquered populations, to reformulate control policies and to facilitate the incorporation of these populations into the colonial system. The ideology of tribe did not disintegrate in India with the end of colonialism. It has been reformulated in the context of the Hindu model of casteideology, a context observable in the conceptualization of adivasi "backwardness" and in the alternatives espoused for social mobility.

A tribe is a territorial community. It means that the tribe has a definite territory in which its members reside. For Example, the Naga, Rengma Naga, Sema Naga and other tribals reside in Nagaland; Garos, Khasis, Khasas live in Assam; Bhils in Madhya Preadesh; Soligas in Mysore; Thodasln in Niligiri Hills of Tamil Nadu, Savara, Konda Reddy and so many of Andhra Pradesh and Chenchu, Lambada, Koyadora etc of Telangana so on. In the absence of a common locality or territory a tribe would lose its uniqueness.

As the definitions of tribe cited above clarify, tribals constitute a collection of families. These collections may have various sizes. These families which normally have blood relationships among themselves could be matriarchal or patriarchal in nature. Every tribe has its own name. Each tribe is known to other tribes by its distinctive name. Example of some Indian tribes: Garo, Khasi, Khasa, Naga, Rengma Naga, Sema Naga, Limbu, Santhal, MUnda, Gond, Kota, Badaga, Urali, Thodas, etc.

Language, Life Style and Religion:

The members of a tribe speak a particular language. Different tribes speak different languages. These languages are not only different from the language of the civilised people, but they themselves differ from one another. Common language contributes much to the development of community feeling. Since these languages do not have a script of their own, education of the tribals has become problematic.

Religion plays an important role in the tribal organisation. The members of a tribe usually worship a common ancestor. Also nature worship is common among them. In addition to the Ancestral worship and nature worship the tribals practise other types of faith such as -festishism, animism and totemism. Magic is also widespread among them. The tribal social and political organisations are based on this religion. Participation in common religious ceremonies functions and festivals contributes to the unity of the group. A sizeable proportion of Nagas, Mizos, Santhals, Oraons and Munda, etc. Have embraced Christianity while some tribals such as Butia, Lepcha Chakma have largely identified with Buddhism.

Each tribe has a way of life of its own. Each tribe has its own way of behaving, thinking, feeling and acting. Each has its own customs, traditions, morals, values, and its own peculiar institutions in brief, its own culture. The very peculiarities of a tribe reveal that it has a distinctive culture of its own.

Archaeological methods help understand the tribal culture as a continuum. Similarly, ethnographic data help explain archaeological facts. Obviously, archaeology and tribal studies have an overlapping area where they complement each other. From the archaeological point of view, the branch of knowledge is called ethno-archaeology while from the tribal studies point of view this could be archaeological ethnography. The only difference is in the approach, whether it is ethnography applied to archaeological facts or vice versa.

The knowledge of archaeology is also necessary for understanding the contemporary tribal situation, as tribal revivalism very often seems to manipulate the archaeological facts for glorification of the past and reconstruction of exclusive tribal history. Recently, archaeological facts have been judiciously used for understanding the ethno-history and this is considered very much relevant in many of the underdeveloped territories which were under colonial subjugation.

Tribal communities provide a rich field of linguistic studies. Many theoretical perspectives in linguistics are linked to the study of tribal communities. Syncretic and diachronic approaches to study tribal cultures are perspectives from linguistics. The perspective in emic-etic debate also has its origin in linguistics. These terms were first introduced by linguist Kenneth Lee Pike, who argued that the tools developed for describing linguistic behaviours could be adapted to the description of any human social behavior. The terms **emic** and **etic** are derived from the linguistic terms phonemic and phonetic respectively.
