THE KALAPANI TERRITORIAL DISPUTE: IMPLICATIONS ON INDIA-NEPAL BILATERAL RELATIONS AND REGIONAL STABILITY

Abstract

The Kalapani territorial dispute, a long-standing yet intermittently prominent issue between India and Nepal, has in recent years re-emerged as a critical flashpoint in South Asian geopolitics. Located at the tri junction of India, Nepal, and China, the Kalapani region—encompassing Lipulekh, Limpiyadhura, and Kalapani—has become emblematic of broader questions concerning historical cartography, national identity, and regional power dynamics. This paper examines the historical roots of the dispute which can be traced back to differing interpretations of the 1816 Sugauli Treaty signed between the British East India Company and the Kingdom of Nepal. The ambiguity surrounding the origin of the Kali River, which serves as the basis for the boundary delineation, has fueled overlapping territorial claims that persist in post-colonial contexts.

The study explores how recent developments, including the publication of updated political maps by both India (2019) and Nepal (2020), have intensified nationalist sentiments and political rhetoric in both countries, straining traditionally close ties. The paper argues that while the dispute has not escalated into open conflict, it has significantly eroded diplomatic goodwill, delayed joint developmental projects, and contributed to public distrust—especially among younger demographics in Nepal. Furthermore, the dispute has broader implications for regional stability, as both countries are critical stakeholders in South Asian connectivity, trade, and hydropower cooperation.

Through an analysis of primary treaties, government statements, media narratives, and scholarly assessments, the paper highlights the underlying factors—ranging from geopolitical positioning to domestic political leverage—that sustain the impasse. The role of external actors, particularly China's strategic presence in the Himalayas, is also considered in shaping the diplomatic contours of the dispute. Ultimately, the paper contends that only through institutionalized dialogue mechanisms, historical reconciliation, and people-centric diplomacy can the Kalapani dispute be de-escalated. Such a resolution would not only restore bilateral trust but also strengthen regional frameworks for cooperation and conflict resolution in South Asia. The Kalapani case serves as a microcosm of the challenges facing territorial negotiations in postcolonial regions, where historical legacies intersect with evolving national aspirations and geopolitical realities.

1. Introduction

The Kalapani dispute is a long-standing territorial dispute between India and Nepal, centered on a 35-square-kilometer area located in the northwestern Himalayas at the tri-junction of India, Nepal, and China. The dispute stems from differing interpretations of the source of the Kali River, which demarcates the border between the two countries. Its origins trace back to the 1815 Treaty of Sugauli, signed between the British East India Company and the Kingdom of Nepal, which designated the Kali River as the boundary between British India and Nepal. However, ambiguities in identifying the river's precise origin have led to conflicting territorial claims. Nepal asserts that the river's source lies west of Kalapani at Limpiyadhura, making the region part of its Darchula District. Conversely, India contends that the river originates east of Kalapani, asserting its inclusion within Uttarakhand's Pithoragarh District. This dispute gained renewed prominence in 2019 when India published a political map showing Kalapani within its territory, triggering strong protests from Nepal. In response, Nepal released a revised map in 2020, incorporating Kalapani, Lipulekh, and Limpiyadhura as part of its sovereign territory. Beyond historical and political complexities, Kalapani holds significant strategic importance. Its location near the Lipulekh Pass, a key trade route connecting India and Tibet, underscores its value for border security and regional trade.

These factors make the Kalapani dispute a contentious and critical issue in India-Nepal relations, with broader implications for regional stability in South Asia.

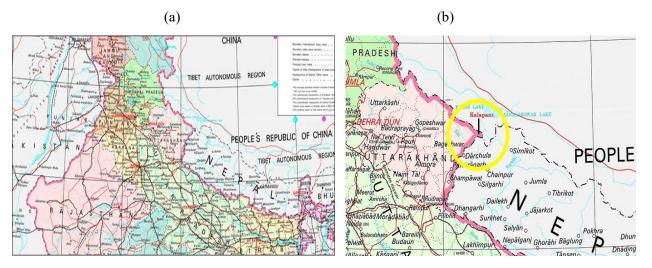


Figure 1: Map (a) Presents India, Nepal and China Trijunction and (b) Represents the Kalapani highlighted in yellow circle [Source: Press Information Bureau]

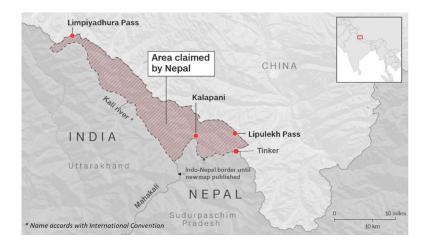


Figure 2: Map representing the disputed territory between India and Nepal

Nepal's publication of a revised map in 2020, asserting its claim over Kalapani, and India's strategic infrastructure projects in the area have exacerbated tensions. At a regional level, the dispute impacts South Asia's geopolitical balance. It provides external powers like China an opportunity to influence Nepal, potentially altering the strategic equation in the region. Furthermore, unresolved territorial conflicts like Kalapani undermine multilateral initiatives such as SAARC and BIMSTEC, hindering economic integration and regional cooperation. Addressing this dispute is essential not only for bilateral harmony but also for fostering stability and development across South Asia.

3. Literature Review: Importance of India-Nepal Relations

India and Nepal share an intricate and multifaceted relationship that is deeply rooted in history, culture, and geography. This bilateral relationship is underscored by economic interdependence, shared cultural heritage, and strategic significance, making it a critical component of South Asian geopolitics. The historical ties between India and Nepal date back centuries, with both countries sharing a common heritage of religion, culture, and open borders. Hinduism and Buddhism serve as significant cultural bridges, with sites like Lumbini in Nepal and Varanasi in India being pivotal in fostering people-to-people connections. Scholars like Singh (2017) argue that this cultural affinity creates a unique bilateral relationship unparalleled in South Asia. Furthermore, the 1950 India-Nepal Treaty of Peace and Friendship institutionalized these historical ties, allowing for mutual migration and economic engagement (Sharma, 2018). Economically, India is Nepal's largest trading partner, accounting for a significant share of its exports and imports. Indian investments in Nepal, particularly in energy and infrastructure, are critical for Nepal's development. Thapa (2020) highlights the role of joint ventures in hydropower projects, which leverage Nepal's vast water resources while addressing India's growing energy demands. Additionally, cross-border connectivity initiatives, such as railway links and integrated check-posts, are transforming trade dynamics, fostering greater economic interdependence (Pandey, 2021).

Nepal's strategic location between India and China amplifies its importance in regional geopolitics. According to Pant (2019), Nepal serves as a buffer state and plays a crucial role in maintaining the balance of power in South Asia. India's interest in Nepal is further reinforced by concerns over China's growing influence, as reflected in infrastructure investments under China's Belt and Road Initiative (Bhattarai, 2020). Scholars emphasize the need for India to strengthen its engagement with Nepal to counterbalance China's strategic advances and maintain its own influence in the region (Kumar, 2021). India-Nepal relations also play a vital role in regional cooperation frameworks such as SAARC and BIMSTEC. Both countries' participation in these multilateral platforms highlights their shared interests in regional integration and development. However, unresolved disputes like the Kalapani issue have occasionally hindered their ability to collaborate effectively within these frameworks (Rai, 2020).

Despite these strong ties, challenges such as border disputes, trade imbalances, and nationalist rhetoric have strained relations in recent years. Gupta (2022) notes that periodic blockades and political disagreements have underscored the fragility of this relationship. Nonetheless, opportunities for strengthening bilateral ties remain vast, particularly through joint development projects, enhanced people-to-people interactions, and diplomatic engagements. The India-Nepal relationship is a cornerstone of South Asian stability, encompassing historical, cultural, economic, and strategic dimensions. While challenges persist, the opportunities for collaboration far outweigh the differences. A nuanced understanding of these dynamics, as reflected in existing literature, underscores the importance of sustained efforts to enhance this bilateral relationship for mutual benefit and regional stability.

Recent studies highlight the interplay between territorial disputes, nationalism, and geopolitics. For instance, a 2023 article in *India Quarterly* examines how the Kalapani dispute has fueled nationalist narratives in Nepal, influencing its foreign policy towards India.

The Kalapani dispute has broader implications for regional stability. 4.1 Trust Deficit

The area of Kalapani is of strategic significance between India and Nepal as it serves as a tri-junction between India, China and Nepal is a "buffer state" between India and Nepal and both countries are great-power aspirations of great power in the region—the Kalapani dispute has important ramifications on the relations between the three. The Kalapani territorial dispute has had profound and multifaceted effects on India-Nepal bilateral relations, disrupting historical goodwill and creating challenges across diplomatic, economic, and political domains. The dispute has amplified mistrust, undermined development cooperation, and inflamed nationalist sentiments, thereby complicating efforts to sustain and strengthen the traditionally close ties between the two nations. The dispute has significantly eroded the foundation of trust that has long underpinned India-Nepal relations. Historically, the relationship has been characterized by open borders, deep cultural ties, and mutual economic interdependence. However, the publication of India's new political map in 2019, which included Kalapani as part of Uttarakhand, followed by Nepal's issuance of a revised map in 2020 incorporating Kalapani, Lipulekh, and Limpiyadhura, marked a turning point. These actions, viewed as unilateral assertions by both sides, fueled accusations of territorial encroachment and intensified diplomatic tensions.

Nepal's constitutional amendment to legitimize its claim over the disputed territories was perceived by India as a politically motivated move, while Nepal criticized India's infrastructure development in the area as a violation of its sovereignty. These events have deepened the mistrust between the two governments, complicating diplomatic efforts to address not only the Kalapani issue but also broader areas of cooperation such as border management and regional security. The trust deficit has also had a cascading effect on people-to-people relationships, leading to increased skepticism about each other's intentions, which were historically harmonious.

4.2 Economic and Developmental Implications

The economic dimension of India-Nepal relations, which has historically been robust, has suffered due to the ongoing dispute. Cross-border trade, a vital lifeline for Nepal given its landlocked geography, has been disrupted as tensions escalate. India is one of Nepal's largest trading partners, and disputes like Kalapani create uncertainties that hinder the seamless flow of goods, services, and investment. 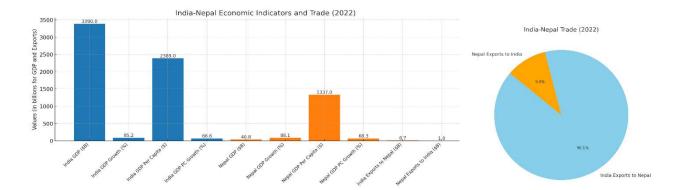


Figure 3: Graph show trade between India and Nepal in 2022

These delays undermine efforts to improve regional trade and economic linkages, depriving both nations of the economic benefits that could arise from stronger integration. Development cooperation has also been affected. Joint initiatives in hydropower development, such as projects aimed at harnessing Nepal's vast water resources for mutual benefit, have encountered setbacks. Cross-border energy trade, which could significantly contribute to Nepal's economic growth and help meet India's energy demands, has been similarly stalled. The Kalapani dispute exacerbates these challenges, as trust is a prerequisite for successful economic partnerships.

4.3 Political Ramifications

The dispute has had a profound impact on the domestic political landscapes of both countries, fueling the rise of nationalist rhetoric and influencing policy-making. In Nepal, the government's strong stance on the Kalapani issue has been leveraged to consolidate political legitimacy and rally public support. The publication of Nepal's revised map was celebrated

The escalation of nationalist sentiments has further complicated bilateral relations, as it creates a climate of zero-sum politics, where any gain for one country is perceived as a loss for the other. This dynamic not only hinders pragmatic conflict resolution but also risks turning public opinion against broader bilateral cooperation in areas of mutual interest. Its effects extend beyond the immediate territorial disagreement, influencing broader aspects of bilateral engagement and undermining opportunities for sustainable partnership.

5. Regional Implications of the Kalapani Dispute

The Kalapani territorial dispute between India and Nepal extends beyond bilateral tensions, influencing geopolitical dynamics, regional cooperation frameworks, and security concerns. Its strategic location at the tri-junction of India, Nepal, and China amplifies its significance, turning a localized territorial disagreement into a potential regional flashpoint with broader implications for South Asia's stability.

These dynamic risks escalating the Kalapani dispute into a broader geopolitical confrontation, potentially drawing in other regional and global players, further destabilizing the region.

5.2 Regional Cooperation

The dispute also poses challenges to regional cooperation through multilateral frameworks like SAARC and BIMSTEC. Both organizations are pivotal for fostering economic integration, connectivity, and collaborative problem-solving in South Asia. However, unresolved bilateral disputes like Kalapani hinder their effectiveness.

In the case of SAARC, the organization has long been stymied by bilateral tensions among its member states, particularly between India and Pakistan. The Kalapani dispute adds another layer of friction, further undermining SAARC's ability to promote regional integration. Nepal's insistence on raising territorial issues in multilateral forums could polarize member states, shifting focus away from developmental priorities and cooperative agendas.

BIMSTEC, which excludes Pakistan and focuses on economic and technical cooperation, offers a more promising platform for regional engagement. However, the Kalapani dispute risks spilling over into BIMSTEC discussions, particularly when connectivity projects, such as the BBIN Motor Vehicle Agreement, are affected by India-Nepal tensions. Disputes like Kalapani undermine trust among member states, which is essential for advancing shared goals.

Regular diplomatic consultations, free from domestic political pressures, are critical for maintaining momentum toward resolution.

6.2 Confidence-Building Measures

Strengthening economic and cultural ties is vital for reducing tensions and creating a conducive environment for dispute resolution. Economic collaboration, particularly in cross-border trade and infrastructure development, can reinforce interdependence and highlight the mutual benefits of cooperation. Projects such as hydropower development and energy trade could be expanded to demonstrate shared economic gains.

Cultural initiatives, including exchange programs, joint celebrations of shared traditions, and people-to-people interactions, can help rebuild trust and emphasize the deep historical connections between the two nations. These measures can also counteract the nationalist rhetoric that has exacerbated tensions, fostering goodwill at both the governmental and grassroots levels.

6.3 Leveraging Regional Platforms

Multilateral organizations like SAARC and BIMSTEC offer opportunities for mediating the dispute within a regional framework. While SAARC has historically struggled with internal divisions, it remains a platform for dialogue on issues affecting South Asia. Engaging SAARC in discussions about broader regional stability could indirectly support bilateral negotiations on Kalapani. BIMSTEC, with its focus on technical and economic cooperation, provides a less politically charged platform for fostering collaboration. India and Nepal could use BIMSTEC to advance shared regional goals,
