

(LRI) for an additional acquisition of an equity stake in Lafarge Iligan, Inc. (LII) and Lafarge Mindanao, Inc. (LMI). LII and LMI are subsidiaries of LRI and will remain as subsidiaries of LRI.


The timeline for the completion of the acquisition of LRI remains the same. The expected completion of the transaction will occur within the second half of 2015.
