

Aboitiz Equity Ventures, Inc. (the "Company") was advised by AEV CRH Holdings, Inc. (AEV CRH) of the filing by AEV CRH of the Amended Tender Offer Report (SEC Form 19-1) with the Securities and Exchange Commission (SEC) for the acquisition of approximately 11.15% of the issued and outstanding shares of Lafarge Republic, Inc. (LRI) (formerly Republic Cement Corporation).

The amendments sought to clarify the corporate name of participating brokers, as well as their contact persons and contact details and to further state that the sale will be subject to the terms and conditions of the Tender Offer as contained in the SEC Form 19-1 and its annexes. The actual signed and notarized copy of the Affidavit of Publication was also attached to the Amended Tender Offer Report.

Copies of the Amended Tender Offer Report were also sent out to shareholders of LRI and will be published in accordance with the requirements of the Securities Regulation Code.


The tender offer period began yesterday, August 11, 2015 and will end on September 9, 2015.
