

Mr. Azanza joined AEV in 2011 as First Vice President – Business Development.

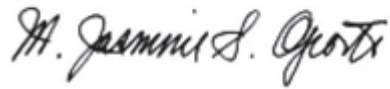
