Pursuant to the approval of the Board of Directors of Aboitiz Equity Ventures, Inc. (AEV) in its special Board Meeting today, AEV executed a Placing Agreement with UBS AG, Hong Kong Branch for the latter to act as the Placement Agent for the sale of at least **63,331,000** AEV common shares held in treasury, via private placement.

AEV intends to sell the shares either in tranches, or in a single block at prevailing market prices or at prices deemed beneficial to the Company, in accordance with the applicable rules of the Exchange.


The proceeds of the sale will be used for general corporate purposes and to fund future investments of AEV.
