For the month of November 2015, there is an increase of business name (BN) registrations compared with the same month last year; up by 4.74% or 20,249 BNs registered from the total recorded, compared with 19,332 registered BNs in 2014. It can be observed that new BN registrations contributed 83.96% or 17,001 BNs to the total registrations for the month. This figure records an 8.27% increase compared with the November 2014 total new registered BNs of 15,702. On the other hand, there are 3,248 2015 renewals or 16.04% to total transactions. This shows a decrease by 10.52% compared with the 3,630 renewals recorded for the same period in 2014.









In terms of territorial scoping (i.e. National, Regional, City and Barangay), Barangay level records 8,933 registrations or 8.52% decrease compared to November 2014 registrations of 9,765. Registrations at the City/ Municipality recorded 5,929 BNs or a 1.42% increase compared to last year's 5,845 BNs registered. Meantime, there are 3,168 BNs registered under the Regional scope November 20-15, or an increase of 76% from 1,800 in November 2014. Finally, BNs registered at the National level is 2,219 (or 11% to total), an increase of 15.45% from last year's 1,922 BNs registered.


Since October to December is a lean season for business registrations, there is a remarkable decrease of -31.16% of the total transactions from October 2015 (26,559 BN registered). In starting up a business, there are certain requirements before a

sole proprietor can operate. Some of the requirements are as follow: barangay clearance, community tax clearance, permit to operate, TIN, and other regulatory permits such as environmental permit and fire permit. Most business permits expire on the 31st of December unless the permits are issued on a quarterly basis. The business permit expiration can be a reason for the downfall of business name registrations. Sole proprietors tend to register their business name every start of the year rather than having it registered during the lean season (October to December) in which permits will be renewed and paid year start and can only be used for a few months*





Based on owner's location, National Capital Region (NCR) registered the most number of BN registrants with 4,185 new and 731 renewals. This is followed by Region 4A with 3,198 and 555 (or combined representing 19% of the total), then by Region 3 with 2,182 and 376 new and renewal registrations, respectively.
