#### **Objective**

The Government of Odisha in School & Mass Education Department is awarding Junior Merit Scholarship under the Scheme 'e-medhabruti' out of the State budget to provide financial assistance to the meritorious Higher Secondary School students of Odisha from families whose parental income does not exceed 6.00 lakhs to meet a part of their educational expenses while pursuing their higher studies.

### Scope

The scholarship is awarded to students pursuing Class XI & XII in the Higher Secondary Schools of the State.

Eligibility conditions for Junior Merit Scholarship

- i. The student must be a permanent resident of Odisha State.
- The Student must have passed HSC with 60% or more marks from an institution recognized by BSE Odisha, CBSE, ICSE, Equivalent Boards, and pursuing regular Class XI courses of 10+2.
- The income of the parents of the students from all sources should not exceed Rs.6.00 lakh per annum.
- Students shall apply for Junior Merit Scholarship in the <u>1<sup>st</sup> year of the course</u> (Class XI).

## Exclusions

The following students shall not be eligible for Junior Merit Scholarship:

i. Students pursuing their higher study through distance learning /correspondence.

- ii. Students already availing scholarship for pursuing their study under any other schemes of State or Central Govt.
- iii. Students studying Abroad.
- iv. Students not validated by the concerned Principal/Institution during Class XI (1st year of his/her admission).

# Merit Criteria For Selection

The following factors will be taken into consideration:

- i. Fulfillment of eligibility conditions as given in the scheme.
- ii. Online authentication/validation of student record by the Principal of concerned Higher Secondary School/Institute.
- iii. Final Merit/ Selection lists of the students will be drawn in terms of percentage of marks obtained in the HSC examination from among the validated students in the merit, proportionately basing on the data. The mode of selection for scholarship shall be made through descending order of merit till it reaches the eligible quota of scholarship. For example, a student who has secured 92% of mark in the last examination shall come first then the one who has secured 91% mark and so on.
- iv. In case of a tie in percentage of marks under a particular type of scholarship and some are to be left out due to exceeding maximum quota of scholarship, then the parental income ceiling will be considered i.e. the student with lower parental income ceiling will get preference.
- v. The CBSE/ICSE grading system in the form of CGPA i.e. Grade points shall be converted to the percentage by multiplying with 9.5 <u>formula Percentage</u> (%) = CGPA x 9.5.

## General Criteria/ Limitations For Award of Scholarship

- i. The Scholarships meant for Class XI Students shall be awarded to boys and girls in 50:50 ratio. In case requisite number of candidates (Boys/Girls) are not available under any gender, then the balance number of scholarships shall be awarded to the other eligible applicants.
- Multiple registrations / applications by a student for particular category of merit are strictly prohibited.

- iii. If any of the authenticated records are found to have invalid documents, the case will be summarily rejected.
- Any type of wrong entry made by students i.e. parental income, maximum and secured mark, percentage of mark etc. leading to rejection of application (i.e. the student fails to be in the final merit list), then the applicant will be solely responsible for the rejection.

### Procedure for Disbursement

The scholarship would be sanctioned subject to fulfillment of the prescribed eligibility criteria by the students and validation/authentication by the Principals of the concerned Higher Secondary Schools/ Institutes in online mode only. Scholarship will be paid to the selected students by the Directorate of Higher Secondary Education through DBT (Direct Benefit Transfer) mode only and will be transferred to Bank account of the beneficiaries.

The students must have an active and valid account in any **nationalized bank which has Electronic Clearing System (ECS)/ Core Banking** facility to facilitate transfer of scholarship amount directly to their account.

The bank account must be in the name of applicant/ student only. Students must enter their Bank/Branch name, saving bank account number and IFSC code very carefully to ensure smooth transfer of scholarship amount.

#### Cancellation of Scholarship

The scholarship sanctioned is liable to be cancelled on the following occasions.

- i. If the student is found to have obtained scholarship by false statements/ fabricated documents.
- ii. If the student discontinues his/her studies, the scholarship shall be stopped from the subsequent year.

#### Duration of scholarship and its Renewal

A student will be eligible for the scholarship for a total duration of the course. Scholarship awarded to any student under State Scholarship Portal is automatically renewable, subject to student continuing in Class XII (2<sup>nd</sup> Year) and online validation / authentication done by the institute.

For renewal of Scholarship for the 2024-25, the names of selected students in previous selection year will be listed in Principal's log in ID. Only students continuing in the concerned academic year has to be authenticated online by the Principal. If any student found to have dropped out/ passed out from the HSS, their records shall not be validated.

The Principal / Head of Higher Secondary School / Institution will be personally held responsible for authenticating eligible students from the records displayed in their log in.

# Announcement and Mode of Submission of Scholarship Application for Fresh Scholarship.

Applications will be invited from eligible students each year on the State Scholarship Portal. All information relating to this scheme will be uploaded in the State Scholarship Portal. Submission of physical application would not be accepted. Only verified online applications will be considered for award of scholarship.

- i. All eligible Students studying in SAMS & Non-SAMS Higher Secondary Schools need to upload the required documents such as <u>family income</u> <u>certificate</u> of the current year, <u>mark sheet</u> of HSC, <u>resident certificate</u> and bank <u>account details</u> (first page of bank account which should be in the name of student), Aadhar Card and Higher Secondary School ID card. For details, instruction manual is available in the State Scholarship portal may please be glanced through.
- ii. Aadhaar Card authentication is mandatory to avoid any duplicity.
- Outside students (students of Odisha but studying outside Odisha) are also required to apply online for this scholarship.
- iv. Application which is not validated / authenticated by the Higher Secondary School/ Institute will be treated as "Invalid".
- v. Merit/ selection list as per quota would be generated from the verified applications.

List of Documents required for Scholarship DHSE-BUDPL-ALLOT-0003-2022/01/2024 The following legible documents will be uploaded at the time of applying under the scheme.

- i. Domicile certificate to be issued by the competent authority, i.e. from the concerned Tahasildar /Addl.Tahasildar. The students whose parents are working under Odisha State Govt. can produce resident proof from the employer.
- ii. Proof of annual income to be issued by the competent authority. i.e. the Revenue Officer not below the rank of Tahasildar or Addl. Tahasildar.
- Mark sheets & Certificate of last qualifying examination i.e. HSC from an institution recognized by BSE Odisha, CBSE, ICSE, Equivalent Boards.
- iv. Bank Account details of the student concerned (First page of bank account containing account number and IFSC).
- V. Higher Secondary School ID card issued by concerned authority. While in the absence of the same, the student may provide Admission receipt/Library Card/Letter of Undertaking from concerned Higher Secondary School authority (Any one).
- vi. Aadhaar Card of the student concerned.

### Role and Responsibility

#### Higher Secondary Schools:

- The Head of Institution has to ensure genuineness of the student i.e. he/she is studying in the Higher Secondary School / Institution for the particular year
- Correct data regarding parental income, marks secured, bank account, Aadhar card details, Higher Secondary School ID card and residence certificate submitted by the applicant to be verified.
- If any error is found in the application of the student, the Principal / Head of Institution will rectify the error. If all data are correct, he/she will authenticate the record of the student to be considered for scholarship by the Directorate. Merit or selection list will be drawn only from the records authenticated by the Principal /Head of institutions within the timeline given for the purpose.
- If any student had applied more than one time, only single record will be authenticated by the principal.

### OCAC through the Service Provider:

- Complete online system for SAMS and Non-SAMS Colleges will be developed as per the prescribed criteria mentioned in the Junior Merit guidelines for the year 2024-25.
- ii. Technical support to all stake holders shall be provided by OCAC, BBSR.
- Submission of Validated data for Fresh applications immediately after the closure of Principal's validation for scrutiny, preparation of selection list at the level of Directorate of Higher Secondary Education.
- iv. Online uploading of guidelines, instructions, letters and round-wise selection list, which have been processed for payment.

#### Directorate of Higher Secondary Education:

- Inviting online applications for award of Junior Merit scholarship through print and electronic media.
- Scrutiny / Verification of validated data received from OCAC.
- Preparation of merit/selection list for Fresh category.
- Online payment to eligible candidate under fresh and renewal category through IOTMS.
