Applications are invited from eligible Indian nationals for a post of **Junior Research Fellow** under a project entitled “DEVELOPMENT OF NOVEL BISPECIFIC NANO-ANTIBODY FOR CLINICAL USE” sponsored by Science and Engineering Research Board (SERB), GoI, New Delhi [GP-452] under Dr. Abhay H Pande, Associate Professor, Department of Biotechnology, NIPER, SAS Nagar. The position is purely temporary, initially for **1 Year**, extendable up to **Two years** based on the performance of the candidate and is co-terminus with the duration of the project.

1. **Essential qualifications:** M.Sc./M.S. (Pharm.)/M. Pharm. in Biochemistry/ Microbiology/Biotechnology/Life Sciences. Minimum CGPA of 6.75 (or 60% marks) for General category, 6.25 (or 55% marks) for SC/ST, 5.75 (or 50% marks) for physically handicapped (PH) candidates on a 10 point scale is required in the qualifying examination.

Desired experience: Experience in cloning, expression purification of recombinant proteins, characterization of proteins.

Age Limit: 28 years.
