



2022-2023 ONLINE APPLICATION GUIDE FOR APPLICANTS

The application for the 2022-2023 Fulbright DAI Program must be completed online. It is important to read and follow the instructions carefully, complete all parts of the application and submit the application by the **deadline of March 10, 2022.**

An opportunity to do so will be included in the program Terms and Conditions document that participants submit when accepting the Fellowship. IREX closs not sell applicant, or current/past participant information.

Consent for the Collection and the Processing of Personal Data from the European Union






