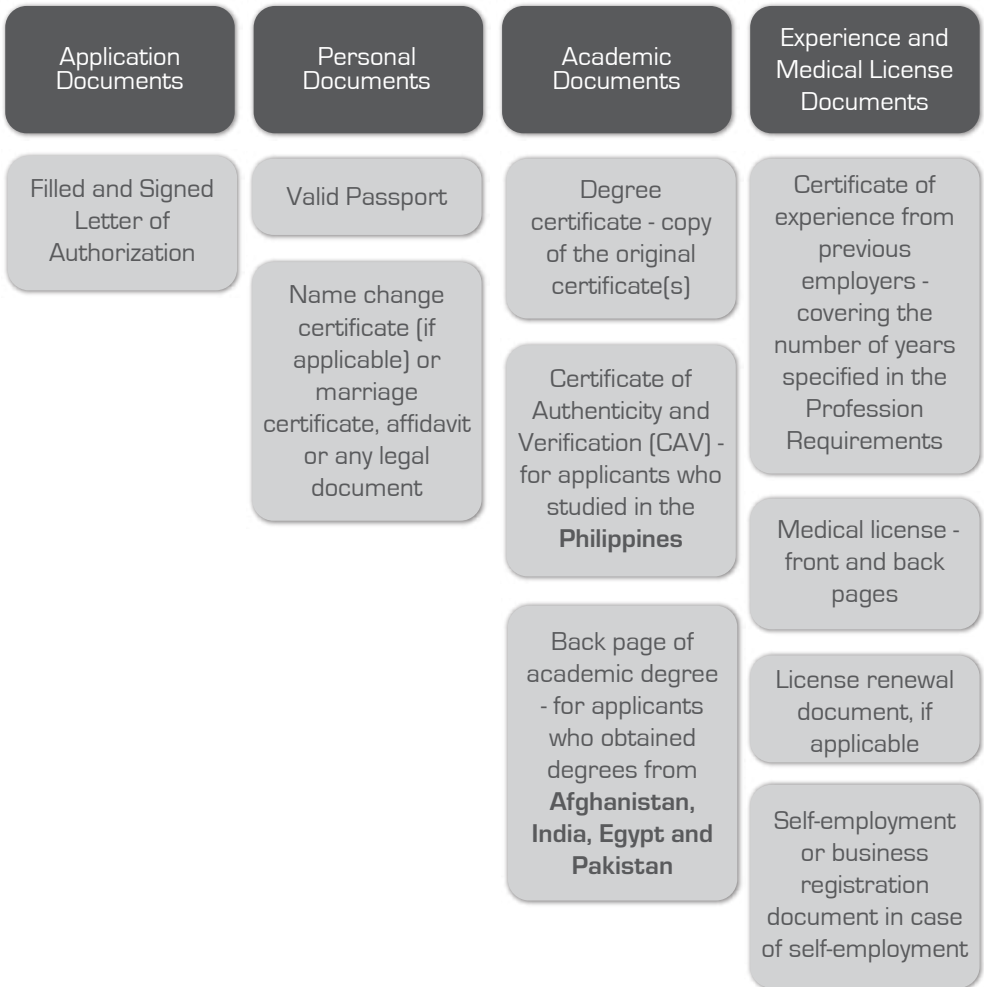

1. Signup (New users)



- Go to www.dfgsch.com
- Click 'Register here'
- Enter and confirm your Email ID
- Read the disclaimer carefully and click 'I Agree' to proceed
- Click 'Register'
- ✓ An email will be sent to you with your login details

- Go to www.dfgsch.com
- Enter the Email ID and Password you received at your registered email
- Click 'Login'

3. Complete the Form



- Read the instructions carefully
- Enter your information in the listed sections

4. Scan and Upload



- Scan and upload your required documents (Refer to the Profession Requirements section)

- You will receive a payment confirmation email, along with a payment receipt, DataFlow Group Reference Number and Transaction Reference Number
- The DataFlow Group will verify your documents and submit the results to the QCHP

6. Re-Verification Process

In case of 'Negative' or 'Unable to Verify' applications, please follow the below steps:

1. Visit www.dataflowgroup.com/QCHPSupport
2. Fill in the required fields
3. Under 'Nature of Query' select 'Re-Verification'
4. Once done, click 'Submit'

7. Important Notes

1. In case of specialty, the Bachelor's Degree should be submitted with the post graduate degrees.
2. If the applicant has worked in Qatar for a period that exceeds the required years of experience for each profession, the medical license from their home country is not a mandatory requirement.
3. If the applicant has never worked in their home country, the medical license from their home country is not a mandatory requirement.
4. If the applicant's home country does not provide a medical license, it is not a mandatory requirement.
5. If the applicant worked in any other jurisdiction, the medical license of that jurisdiction is a mandatory requirement.
