



Update on PSV Services - Circular for the DataFlow Group

As part of the Department of Healthcare Professions'(DHP)/Ministry of Public Health’s pursuit to enhance the Registration and Licensing process for healthcare practitioners in all professions, thereby streamlining the verification process overall, the DHP in collaboration with the DataFlow Group has reduced the processing time of verification applications, updated the PSV services and introduced new optional services as listed below.

- Processing Time reduced to **20 Working Days**.
- New services introduced for the following categories: **“Trainee with no experience”, “Clinical Nurse Specialist/ Advanced Nurse Practitioner/ Nurse Educator”,** and **“Visiting Doctor - Short Notice”**.
- Optional Premium Services are added: **SMS Service, Express Service, Applicant Assist.**
- Applicants can now submit a maximum of **3 Work Experience certificates** instead of 2 in the Employment component at the **same price**.
- Change in price when applicants have more than 3 Work Experience certificates and request for additional, from 180 QAR to **300 QAR**.

- An additional 50 QAR admin fees will be added to the above-mentioned prices in case payment is done at dataflow counters (no.9, 14) in the MOPH premises.

SMS Service	An optional service for applicants to receive regular messages related to the checks and status of their case as it progresses	QAR 9.47
Express Service	An optional service for express processing of an application. The applicant has the option of upgrading their services to a prioritized document verification service for an average turn-around time of 14 working Days	QAR 492
Applicant Assist	An optional service where applicants need assistance/help in filling up the Dataflow application. Applicants will fill the essential (limited) information and upload the documents. A Dataflow Group associate will assist the applicants in completing the online application on their behalf within 2 working days	QAR 146
