CORPORATE BUYER COMPLETE REQUIREMENTS

1. 2 valid government or company-issued IDs for Authorized Company Representative
2. 2 copies of the Certificate of Registration, Articles of Incorporation/Partnership/Association and By-Laws of the corporation as registered in the Securities and Exchange Commission duly certified by the Securities and Exchange Commission or the Corporate Secretary of the Corporation.
3. 2 originals of the Secretary's Certificate, attested under oath, of the valid resolution of the Board of Directors/ Governors/ Trustees authorizing the purchase and mortgage (if through financing) of the property and its terms designating and appointing the official authorized to negotiate and sign documents on behalf of the corporations.
4. 2 original and notarized copies of a certification under oath by the corporate secretary of the corporation as to the nationality of its stockholders.
