Under Philippine laws, only FILIPINO CITIZENS may aquire a house and lot in the Philippines. Foreign Nationals may purchase Condominium unit/s.  
If the buyer is legally separated he/she must submit a copy of the court order or decree granting the legal separation. This is to be submitted upon signing of the Contract to Sell to facilitate registration of the said property.  
If a married buyer wants to indicate that there is a separation of properties between him/her spouse, a copy of the court order to this effect should also be submitted upon signing of the Contract to Sell.  
If a buyer wants to register the property in behalf of his/her children who are minors, a copy of the guardianship or trusteeship papers must be submitted upon signing of the Contract to Sell.  
If buyer is a balikbayan under the governments program, he/she must submit an affidavit showing the date and place of the transferee’s birth, the names and addresses of his/her parents, spouse and children, if any: the area, the location and the mode of acquisition of his land holdings in the Philippines, if any, his intention to reside permanently in the Philippines, the date he/she lost his/her Philippine citizenship; and the country of which he is presently a citizen. This is a required document for registration of the property and must be submitted upon signing of the Contract to Sell.
