TERMS AND CONDITIONS

The reservation for the Property is good only for a maximum period of thirty (30) calendar days from my/our payment of the Reservation Fee or up to _____ (the "**Reservation Period**"). I/We understand that the Reservation Fee is **non- refundable** should I/we decide to cancel my/our reservation for any reason whatsoever, whereupon my/our Reservation Fee shall be deemed forfeited in favor of the **Seller**.

I/ We hereby acknowledge the right of the **Developer** to correct the figures appearing herein in the event errors in pricing and computation are discovered at any time. Furthermore, I/we hereby authorize and/or allow the **Developer** to deposit my/our check covering my/our reservation fee prior to the acceptance or approval by the **Developer** of our reservation application. In case my/our reservation application is not accepted or disapproved by the **Developer** for any reason whatsoever, I/we hereby agree to accept the full refund of the reservation fee without interest.

I/We understand that the Seller reserves the right to accept or deny this request for reservation. No payment made to any individual, realtor, broker or employee of the **Seller** in favor of or for transmittal to the **Seller** shall bind the latter unless and until such payment is actually received and duly receipted by the **Seller**. In the event of acceptance, I/we agree to pay the relevant down payment, (for local buyers) deliver the postdated checks covering the balance of the Purchase Price in accordance with the above terms of payment, and execute(as applicable) the Contract to Sell or Deed of Absolute Sale(provided title for subject property has been issued by the Register of Deeds), such documents being in the form prescribed by the **Seller**. All checks that I/we shall issue shall be made payable and crossed to the **Developer** only. I/We hereby further understand that any representation or warranty made to me/us by the agent who handled this sale not embodied herein shall not be binding on the company unless reduced into writing and confirmed by the authorized signatories of the **Developer**, and this contract shall not be considered as changed, modified, altered or in any way amended by acts of tolerance of the **Developer** unless such changes, modification or amendments are made in writing and signed by the duly authorized officers of the company.

I/we acknowledge that the **Developer** shall have the right to automatically cancel my/our reservation without further notice and forfeit as liquidated damages my/our reservation fee and whatever other payments I/we have made in the event of the following:

a.Failure to pay the reservation fee check I/we have issued without need of notice or demand on the part of the **Developer**;

b.Failure on my part to sign and/or deliver any and all necessary documents as required by the **Developer** to execute the Contract to Sell; and

c.Withdrawal on my part from this Agreement for any reason whatsoever.

I/we hereby understand and agree that the **Developer** will be authorized and entitled to offer my/our unit to other prospective buyers and forfeit my/our payments as liquidated damages. Notice (if any) sent to my/our given address by registered mail shall be considered served and received within 5 days from date of posting if within the Philippines and 15 days from date of posting if outside of the Philippines.

I/We understand that the availability of the Property/ies is subject to approval and acceptance by the **Developer** at its sole discretion. In the event that the above Property/ies is/are found to be not available for sale for any reason whatsoever, the **Developer** shall have the option to cancel or to disapprove this reservation, and any and all amounts shall be reimbursed in full without any interest. I/We, however, may agree to transfer my/our payments, without interest, to another available unit.

Should my/our reserved Property(ies) be part of the Consolidated Leasing program of the **Developer**, I/we undertake to abide by the terms and conditions of the program and execute the Consolidated Leasing Agreement therefor. Further, I/we acknowledge the Developer's right to adjust the number of floors and/or units under the program as it deems appropriate, without need of prior notice to me/us.

I/We understand and agree that this Agreement only gives me/us the right to purchase the Property subject to the fulfillment of the conditions herein stated. No other right, title or ownership is vested upon me/us by the execution of this Agreement. The **Seller** retains title and ownership of the Property until I/we shall have fully paid all amounts due to the **Seller** for the purchase of the Property.

The **Seller** may, in its discretion, following my/our submission of a request in writing, allow me/us to: (i) transfer this reservation to another individual, or (ii) transfer this reservation in favor of another property of the **Seller** whether in the same or another project, subject to applicable processing fee and submission and/or execution of documents necessary or required to effect the transfer.As applicable, I/we undertake to obtain the prior written consent of my/our co- owner or spouse to such transfer before the **Seller** can implement my/our request.

I/We warrant that the information which I/we provided herein, whether personal or corporate, is true and correct as of the date hereof and agree to directly and personally inform the **Seller** in writing of any changes in my/our personal data such as but not limited to name, address and/or status. It is understood that the **Seller** shall have the right to solely rely on the information provided by me/us and it shall not be held responsible for any error, non- communication or miscommunication in the personal information I/we have given.

In compliance with data privacy laws, I/we further authorize the general use and sharing of my/our information obtained in the course of this transaction with the **Developer** and/or any of its assigns, agents or representatives, affiliates, and subsidiaries, including personal information and sensitive personal information, as defined by law (collectively, the "Data"). I/We understand and acknowledge that, for a period of ten(10) years from the conclusion of this transaction or until the expiration of the retention limits set by applicable laws, whichever comes later, the Data may be continuously collected, processed, stored, updated and even shared or disclosed by the **Developer** and/or any of its assigns, agents or representatives, affiliates and subsidiaries, to government authorities, to banks or credit information bureau, and to any third party who acquires or will acquire the rights and obligations of the **Developer** , or who processes or will process the Data on behalf of the **Developer** (including, but not limited to, courier agencies; telecommunication information technology companies; payment, payroll, collection, training and storage agencies; entities providing customer support; and such similar parties), or who requires the Data for market research, marketing and advertising, product and business analysis, or audit or administrative purposes, but only (i) for legitimate purposes, or (ii) for implementing transactions I/we have requested, allowed or authorized, or (iii) in order to receive new and related services of the **Developer** , or (iv) in compliance with the **Developer's** internal policies and reporting obligations to government authorities following applicable laws.

Moreover, this Agreement shall automatically terminate upon the execution by the parties of the Contract to Sell.
