

## Instructions:

- Candidates having qualified for Admission to Ph.D. programme for 2022-23 (Special Round-2) are instructed to submit the pre-registration fee only after obtaining the consent of the Supervisor.
- Duly-filled and signed Pre-registration form along with requisite documents [whichever applicable] are to be submitted in hard copy to the University in person from 10<sup>th</sup> – 12<sup>th</sup> January, 2023 between 11:00 AM to 5:00 PM.
- Candidates are informed to refer [List of Available Supervisors for the Admission in the Ph.D. Program for the Academic Year 2022-23 - Updated](#) dated 08-October-2022, for taking consent of the Supervisor. [Supervisor available in the list shall only be consulted for Ph.D. Admission 2022-23]
- Candidate, having taken consent from any existing Supervisor other than the above list, shall not be permitted to submit pre-registration form and his/her candidature shall not be considered as confirmed for Ph.D. Admission 2022-23.
- NOC [wherever applicable] and Migration Certificate are to be submitted in Original.
- Candidates having pursued Master's Programme from Gujarat Technological University are not required to submit Migration Certificate.
- Candidates are informed to verify all the details thoroughly before submitting an application in order to avoid rectification/s at a later stage.
- Candidates not working anywhere are eligible to apply under Full-Time mode only.
- During fee payment, please insert the data in all the mandatory fields. [for Reserved category candidate - select 11,000 under TUITION FEE\_SC\_ST\_SEBC cat. \* & select "0" under TUITION FEE\_General cat. \*]
- Please refer to Page No. 37 & 38 of [Ph.D. Regulations, 2022](#) for Payment of Fees. [Note: (1) Tuition Fee/Registration Fee/Caution Money Deposit/Enrolment Fee/Other Fee are to be paid for the first time. (2) Tuition Fee (as applicable) is to be paid for subsequent semesters then onwards]
- Total Fee Amount to be paid during Pre-registration:
  - (i) Reserved Category - Tuition Fee 11,000 + Registration Fee 1,000 + Caution Money Deposit 1,000 + Enrolment Fee 150 + Other Fee 200 = Total 13,350 (INR)
- The Thesis Evaluation Fee of 8,000 (INR) is **not** to be paid along with this.

- The link for filling Pre-registration form will remain activated from 5<sup>th</sup> January to 10<sup>th</sup> January, 2023 upto 06:00 PM only and therefore it is informed to fill the form timely to avoid last minute rush.
