- Minimum rate of Discount for printed Books:

Once quoted, the Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers shall not make any subsequent discount changes, whether resulting or arising out of any technical/commercial clarifications sought regarding the EOI. Such price changes shall render the EOI liable for rejection.
9. Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers shall quote the discount percentage of items as mentioned valid for 2 years.
10. The Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers should have office in Gujarat state.
11. Authorized Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers should have average turnover of Rs. 25,00,000 of the last two financial years.
12. Discount policy will not be applicable for Government/Non Profit/ Special Category Publications.
13. Discount for journals in certain cases (long term subscription) must be offered.
14. The University may consider more than one the Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers if discount will be same and shall be free to purchase books from any one or more of them. Final decision regarding this shall be decided by the Competent Authority.
15. Exchange Rate for foreign currency shall be calculated as per GOC Rate declared from time to time and the GOC rate must calculate/consider on the bases of purchase order date. In exceptional case, Bank Rate declared by RBI will be applicable.
16. Recommendation of the Books/Electronics resources will be sent by Head/HOD of the P.G. School of GTU.
17. The duration of the EOI is initially for a period of 2 year, extendable to a further period with same terms and condition subject to approval by competent authority.
18. The Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers shall supply books/other items free of postage, packing and forwarding charges.
19. The University shall not make any advance payment (except electronic books/journals/ database) to the supplier for the orders made by the Gujarat Technological University. The payments shall be released by the Gujarat Technological University against the bill (s) received from the supplier after having received the books in good state. The partial payment is not allowed.

2. The Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers can quote the maximum % of discount for all the publishers, and they have to supply minimum 95% of books, from order received from GTU.
3. The Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers has to submit Latest Authority Letter of corresponding publisher.
4. Payment for books/resources price in foreign currency will be made as per latest GOC rate and calculation results in Indian Currency.

8. It is to be certified by the Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers of foreign publishers that there is no Indian edition or paperback edition is available for the same.
9. The price of the book will be as per the price printed on the book only. The Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers has to submit the latest catalogue both in hard and soft copy only, which contains the complete list of books from the quoted publishers.
10. Bill should be submitted in triplicate.
11. The offer of maximum % of discount by the Authorised Publishers/ Booksellers/ Suppliers/ Vendors/Retailers/Wholesalers/Aggregators/ Authorized dealers for respective publication(s) will be applicable to all books published by the respective publishers.
12. Area of Jurisdiction will be Ahmedabad only.

 - If the price, publication date, edition etc. are misrepresented by any means.
25. Maximum percentage of discount will be counted on the MRP mentioned in the book at the time of delivery of the same.
26. The security deposit will be refunded after successful completion of EOI Tenure.
