## Option Selection for students after the declaration of Merit based Progression result

  - GTU has issued above mentioned Circular (3) on Guidelines regarding Summer 2020 Examination on the basis of above mentioned (1 and 2) Education Department's resolutions.
  - University has given Merit based Progression as described in above mentioned Education Department Resolutions to all regular, remedial and special term extension students except regular students of final semester of UG,PG and Diploma courses.
  - If students whose merit based progression result is/will be declared and if they want to improve their grade in **University Theory Examination** then they can appear in the special examination which will be conducted by University. Time table for the same will be declared on GTU website soon.
  - Students whose merit based progression results are already declared by University is mentioned in Table-A, This students will have to choose any one option out of the below mentioned two option through their student portal from 01/10/2020 to 09/10/2020. Once the deadline will get over, no request regarding the extension of the same will be entertained by the University

Option 1: I accept Merit based Progression result and I don't want to appear in Special examination.

Option 2: I don't accept Merit based Progression result and I want to appear in Specil examination.

Result which will be secured in Special Examination will be acceptable to me even if it will be adverse compared to Merit based Progression result.

If student will not select any of the two options, then by default option (1) will be considered for such type of students.

Students who selects option (2) will have to submit exam form and will have to pay exam fees through their student portal. Circular regarding the same will be uploaded on GTU website.

- For the other Courses/Semester for which the declaration of Merit based Progression result is pending, the option selection for such students will start soon after the result declaration. Circular regarding the same will be displayed on GTU website.
- This special examination will be conducted in offline descriptive mode from exam center.
