Appointment of Academic Coordinator for Implementation of NEP-2020

The Ministry of Education, Government of India published the National Education Policy-2020. Based on the NEP-2020, UGC, AICTE and other regulatory bodies have taken various initiatives to transform the higher education institutions. Gujarat Technological University is constantly taking several actions for the successful implementation of such government policies. Some of the main initiatives include adoption of Academic Bank of Credits, adoption of MOOCs into curriculum and translating technical books in Gujarati language.

For the successful implementation of such initiatives and policies at institute level, all GTU affiliated institutes have to nominate an Academic Coordinator in their institutions. The role of the Academic Coordinator is to disseminate information as well as coordinate with GTU on various education policies of the State/Central Government. The coordinator has to engage in the activities related to various initiatives taken by UGC, AICTE, COA, PCI and other regulatory bodies on NEP-2020, MOOCs, Multiple Entry/Exit etc. GTU will create new email ids for Academic Coordinators and further information will be shared to the institutes on these email ids for smooth implementation of NEP-2020. All Institutes are informed to appoint the Academic Coordinator on or before 5 days from the date of the circular. The details of the coordinator need to be filled in the following Google form -
