This is to inform all concerned that the University has decided to organize 12th Annual Convocation in the month of January-2023. The students, who have cleared all the prescribed norms for award of the degree/diploma in 12th Convocation (i.e., Who had passed in the Summer-2022 Examination) have to fill an online application form.

For benefit of student, GTU has introduced and implemented to fill the convocation form and fees for Final Degree/Diploma certificates before submission of the exam form fees of the final semester/year (regular)/pending remedial exams of all courses from summer-2022 Examination and at that time we have deactivated the option to select for "In Person" in the convocation application form Due to covid-2019.

University has decided to invite students in the 12th Annual convocation and we are activating the option of selection criteria to attend the convocation and receive certificate <u>"In-Person or Absentia"</u> under **Convocation tab** in the student portal www.student.gtu.ac.in.

All the students who have **passed Summer-2022 examination** i.e., 12th annual Convocation Eligible students for all Degree courses including Ph.D., (except for Diploma courses) have to select the option of <u>"In-Person or Absentia"</u> and if any student have not selected any option, then by default it will be considered as **absentia**.

The online selection criteria option of "In-Person or Absentia" will be available from **09-12-2022** at **12.00 noon** onwards on GTU website: www.gtu.ac.in in Student Zone under Convocation option or at the student portal www.student.gtu.ac.in under Convocation link.

The last date to fill the online selection criteria option of "In-Person or Absentia" is 23-12-2022.
