### **100 ACTIVITY POINTS**

#### FAQs related to "100 ACTIVITY POINTS"

#### Q1 For whom 100 activity point system is applicable?

➤ Those students who are admitted to the 4 years B.E. and B.Pharm program from A.Y 2015-16 and from A.Y.2019-20 respectively and 3 year B.E. and B.Pharm (Diploma to Degree) program from the A.Y. 2016-17 and from A.Y. 2020-21 respectively.

#### Q2 How this program will be evaluated?

Examiner will evaluate each student after verifying the certificates/ proof as claimed by students.

### Q3 Can the ongoing co-curricular and extracurricular activities of any college be included in this program?

Yes, Suitable activities can be informed to concerned authority in GTU before **31st May** of every year. After approval such initiatives can be included under 100 activity point system.

### Q4 Can a detained student participates in activities in the period of detention and if so whether it will be considered while calculating 100 activity points.

No, whenever he will become regular then only may participate.

## Q5 What is the minimum duration of workshop to be considered as a legitimate activity for fetching desired scores?

Minimum 1-day (6 hours) duration will qualify for such consideration.

#### Q6 Who will certify the participation and performance of the students?

The organizing committee activity /prescribed authority associated with the program at the university or zonal level, competent college authority can certify the participation and performance of the concern students. In case, if the student has genuinely done/participated in some activity, but the specified proof is not available with him/her then college can issue the certificate/letter endorsing the claim of the student.

#### Q7 How can the points be allotted for any activity?

➤ If the claims/ certification by student is validated by Examiners while interacting with them then the student will fetch full score which is assigned for that sub activity at that level. If otherwise he will score zero under the claimed sub activity. (if approved then student will get full points for the activity and if Not approved then student will get zero points for the activity)

## Q8 Can one student participate and score in multiple events under particular sub category?

Yes. In events like Tech fest and others a student can participate in multiple activities in particular academic year and successful participation/performance will be considered for scoring points in those events/activities. (Considering capping i.e. maximum points under that major head of activity).

#### Q9 Who are eligible for the Internal Approval by Examiner?

➤ Only regular semester students are eligible to add/submit their certificate on portal and for the internal approval by examiner.

#### Q10 What would be the role of Examiner in 100 Activity points system?

- During internal approval, student have to provide the furnish supporting documents/reports while appraising him/her about progress. The Examiner will verify the claims and approved the same. The points of the activity is credited as per the guidelines given by GTU. Examiner has to ensure that the activity for which, score/points has been already awarded are not claimed in subsequent evaluation(s).
- After the evaluation by examiner, student has to further verify the claims in their student portal for 100 Activity points and take inputs from Examiner for any query.

### Q11. Can one activity done by a particular student be considered for awarding score in that particular academic year or it can be done later on too?

➤ The participation date on the certificate is consider. If it falls on that academic term then the student will get the point for that academic term only.

### Q12. Which activities/ sub activities will be considered as valid activities for evaluation during university examination for 100 point activity systems every year?

All activities / sub activities listed in the GTU 100 Activity Points list will be considered. If any college has developed any other activity apart from list given by University and taken prior approval from GTU sufficiently in advance, then that activity / event will be included by University in List of activities and will considered.
