Note :-

1. The term of chairperson and members of committee shall be for a period of 2 years from the date of the issue of this document. Special invitees shall continue as member for period of 2 years or till they remain as student of GSMS, whichever is less.
2. The quorum of the meeting of DSGRC including chairperson but excluding special invitee shall be three.
3. DSGRC will follow principles of natural justice for the grievance(s) placed before the committee.
4. DSGRC shall submit its report with recommendations (if any) to Vice Chancellor, with a copy to aggrieved student(s) within 15 days from the date of receipt of the complaint.
