Subject: Registration of MOOC(s) through Student Portal for the Students who have completed / registered MOOC(s) offered by GTU in July-2025 and January-2026 respectively

In line with the implementation of National Education Policy (NEP) -2020, GTU has introduced MOOCs in various programs from A.Y. 2024-25. All enrolled students in Diploma Engineering/UG/PG (as mentioned in Ref.1) of A.Y. 2025-26 were given the opportunity to register themselves for MOOCs (Massive Open Online Course) two times i.e. in July-2025 and January-2026.

Institutes are hereby instructed to inform and guide all concerned students of their institute to complete the registration process for their respective MOOC(s) through the Student Portal on or before **16th February 2026**.

Instructions:

1. Those students who have registered on SWAYAM/NPTEL in July-2025 and January-2026 are required to register themselves through the 'GTU Student Portal' using their credentials under the 'MOOCs Registration' tab.
2. It is mandatory for all concerned students who have registered on SWAYAM/NPTEL in July-2025 to do the registration in both phases (i.e. Registration Phase and Exam, Result and Exemption Phase) on this portal for ensuring credit transfer.
3. Students registering for MOOCs in January-2026, have to register in Registration Phase only.
4. Institutes have to monitor and ensure that all concerned students have completed the registration within the stipulated timeline.
5. No separate offline registration will be entertained by the University.
