# Procedure for Pre-VIVA Thesis submission in the form of Soft Copy for M.Pharm (only for DP-II students) (Applicable only for Summer-2024)

University has adopted digital methods for thesis submission and dissertation. The university has decided to store and maintain thesis of M. Pharm in digital format. Therefore, Institutes and Students will have to submit soft copy of their thesis to the University. Institutes and Guides of students are also directed to keep thesis in digital format for future reference. Students are advised to print required copies only of their thesis for Final Dissertation.

Therefore, thesis submission process will be as mentioned below.

#### ❖ Pre Viva- Submission of Soft copy (submission through Institute)

- 1. The thesis should be in the format specified in thesis submission guidelines.
- 2. Students will have to get signature on all certificates and reports of his/her Guide and Principal. Signature and Seal (wherever applicable) on all certificates is mandatory including review cards of DP1, MSR, DP2 (For Remedial Students) and Plagiarism certificate/report.
- 3. Digital Signature/image of signature or image of institute's seal is not allowed. Students will have to get an original signature/seal on a physical document.
- 4. Then scan copy of these certificates/documents shall be merged with soft copy of the thesis. Students will have to submit one soft copy of the thesis (in pdf format) to the institute. Also note that "Thesis approval certificate" will be provided by the University after successful completion of Viva.
- 5. Soft copy to be submitted by Institutes through GTU portal for Dissertation Planning on below link: <a href="http://studentprojects.gtu.ac.in">http://studentprojects.gtu.ac.in</a>.
- 6. The plagiarism check related guidelines is already provided to institutes via Email. Hence it is essential to follow guidelines for plagiarism check. (Ref No: GTU/Circular/Central Library/2024/1917 dated: 11-03-2024)
- 7. A student and his/her guide will be responsible for any claim of plagiarism in future.
- 8. **Presentation/viva will not be scheduled** for those students who will not submit a soft copy of their thesis before given deadline.
