The iBF Executive Programme is jointly organised by International Enterprise (IE) Singapore and Singapore Business Federation (SBF).

The iBF Programme supports Singapore-based companies in the training of company executives to acquire business knowledge and build networks in selected supported markets like Russia.

Only a maximum of **30 participants** will be accepted for this programme.

Programme Objectives

The programme is specially organised for:

- **Senior management from Singapore-based companies** who have existing businesses and/ or are keen to explore business opportunities in Russia
- **Senior officers from public sector organisations** who support business initiatives that add value to Singapore and Russia

Programme Highlights

- Programme Lessons will be conducted in English by prominent Russian academics from **National Research University - Higher School of Economics (HSE)** as well as senior government officials and business experts.
- A Certificate of Attendance will be awarded by HSE.
- Topics to be covered extensively in this programme include:
 - Overview & analysis of Russia's economy
 - Key industries and developments in Russia
 - Business culture in Russia
 - Banking and Financing in Russia
 - Labour laws and practices in Russia
- **Site/ Factory Visits** to Baltic Pearl and selected Russian companies
- **Networking Sessions** with Russian business leaders, entrepreneurs, young professionals, and government officials
- **Briefing Sessions** by Russian banks, companies, chambers and government officials
- **Market Surveys and Cultural Immersion tours** in Moscow and St Petersburg

Course Fee

Estimated S\$1,670 per participant after 70% support from IE Singapore; only applicable to eligible Singaporean or Singapore Permanent Residents from Singapore-based companies or public sector organisations in Singapore.

In addition, IE will provide support for up to 50% of economy return airfare and accommodation for eligible participants from Singapore-based companies.

Estimated Full Course Fee of **S\$5,570** per participant applies for non-Singapore Citizens and non – Singapore PRs.

Participants who are paying full course fee from eligible companies, can qualify for Double Taxation Deduction (DTD) for airfare and accommodation costs incurred for up to 2 participants per eligible company. For enquiries on DTD, please call IE Singapore at 1800 4377673.

Hotel accommodation, airfare, airport transfers and other incidental expenses will be paid by participants.
