

#FINDTHESTOCK Terms & Conditions

Terms and Conditions:

1. Eligible participants refer to participants who are **new customers to Phillip Securities Pte Ltd (“PSPL”)**.
2. Trading credits are only credited to new Phillip Investment Account holders per NRIC/Passport/FIN number who took part in #FINDTHESTOCK.
3. Trading credits are applicable only for **new customers to PSPL** who open Phillip Investment Accounts and Phillip Cash Management Accounts from 30th Jul 2018 to 15th Aug 2018 (“Eligible Accounts”).
4. Phillip Investment Account is inclusive of Margin (M), Custodian (C) and Prepaid (CC).
