- Deposit: A deposit (amount stated above) placed as credit card guarantee. This deposit will be used to offset the cost of lost instruments. The balance of the deposit will be refunded, if the instrument is returned in good condition. Credit card grantee deposit will be executed within 1 month after the conference.
- Cancellation Fee – if a cancellation is received on/after 16 Sep 2019, a handling charge equal to 50% of the Rental Price will be imposed. Otherwise, the Exhibitor (the Hirer) will be liable for the full cost as indicated above (excluding deposit).
- Late order if accepted after 16 Sep 2019 and on-site orders will be levied a 50% surcharge. For on-site orders, exhibitors will receive the equipment on the following day.
- Collection of Scanner – Scanner can be collected from registration counter at 07:30 hours on 16 Oct 2019, provided payment is made or evidence of payment can be shown, and they should be returned to the same office immediately after Exhibition Closes on 18 Oct 2019.
- Exhibitors are responsible for the use of the scanner. Unit(s) damaged or misused, exhibitor will be charged at full cost.
