WHY INVEST IN ARKK?

- 1. Exposure to Innovation:** Aims for thematic multi-cap exposure to innovation across sectors. ARK believes the securities held in ARKK present the best risk-reward opportunities from ARK's innovation-based themes.
- 2. Growth Potential:** Aims to capture long-term growth with low correlation of relative returns to traditional growth strategies and negative correlation to value strategies.
- 3. Tool for Diversification:** Offers a tool for diversification due to little overlap with traditional indices. It can be a complement to traditional value/growth strategies.
- 4. Grounded in Research:** Combines top-down and bottom-up research in its portfolio management to identify innovative companies and convergence across markets.
- 5. Cost Effective:** Provides a lower cost alternative to mutual funds with true active management in an Exchange Traded Fund (ETF) that invests in rapidly moving themes.

FUND DESCRIPTION

"The Cornerstone Themes of Disruptive Innovation" — Securities within ARKK are expected to focus on and benefit from the development of new products or services, technological improvements and advancements in scientific research related to, among other things, disruptive innovation across ARK's themes: Next Generation Internet, Autonomous Technology & Robotics, Genomic Revolution, and technologies that make financial services more efficient ("Fintech Innovation"). ARKK is weighted across different disruptive innovation elements as shown below:

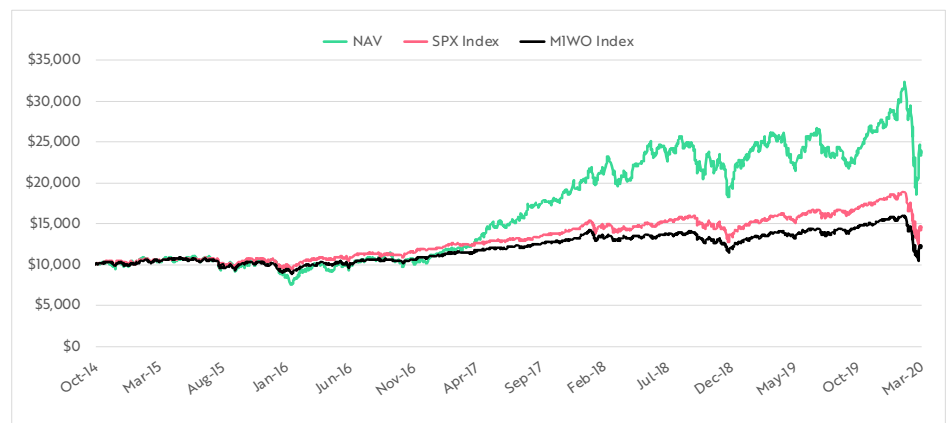
