- The top countries represented include Japan, United Kingdom, Canada, France, Germany, Switzerland, and Australia.

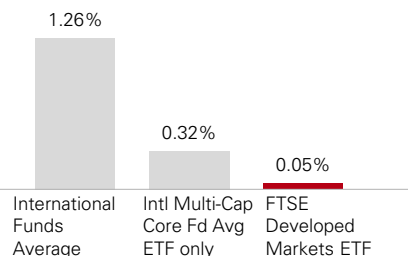
