## **MindChamps Reports 2019 Revenue up 46%, Net Profit up 7%**

**Singapore, 27 February 2020** – MindChamps PreSchool Limited (MindChamps) reported revenue in 2019 of S\$53.9 million, an increase of 46% from 2018.

The revenue growth was attributable mainly to an increase in the number of enrolled students as a result of the acquisition of preschool centres.

For the 12 months ended 31 December 2019, MindChamps reported higher numbers compared to the same period last year:

1. Revenue of S\$53.9 million, an increase of 46%;
2. Gross Profit of S\$27.4 million, an increase of 23%;
3. Profit before tax of S\$7.3 million, an increase of 7%; and
4. Profit after tax of S\$6.9 million, an increase of 7%.

MindChamps holds the number one market-share position among the premium range of Singapore preschools, and is on track for further growth as it further expands into global markets. In 2019, MindChamps has seen an overall increase in student enrolments as well as a growing presence internationally, especially in Australia. To date, there are 21 centres in Australia.

David Chiem, Founder CEO & Executive Chairman of MindChamps said, “2019 was an exciting year for MindChamps, as we expanded into new markets. Our vision for 2020 is to continue this growth across our existing platform. The strength of our international reputation was seen during the launch of our 21<sup>st</sup> centre in Australia, our first Australian greenfield franchise centre.”

Launching the centre, the New South Wales Minister for Health and Medical Research, the Hon. Brad Hazzard said: “MindChamps is mind-blowing. ... There is nothing more important than an education and nothing more valuable than an educator who can inspire. The whole structure and ethos of MindChamps is built around that.”
