

GRABHITCH JUNE 2018 LUCKY ACTIVE BONUS TERMS AND CONDITIONS

- Eligibility
 - All GrabHitch drivers registered in Singapore are eligible to participate in this contest.
 - GrabHitch drivers are reminded to keep within the LTA carpooling restriction of 2 trips/day (each trip may consist of multiple pickups along the way).
 - Individuals who are suspected to be gaming the system will be thoroughly investigated and GrabHitch reserves the right and discretion to take the necessary actions in such instances, including disqualifying participants from the contest.
- Mechanism
 - The stipulated contest period is from 00:00:00 June 1, 2018 to 23:59:59 June 30, 2018
 - Participants have to complete **all requirements** in any tier to qualify for 1 entry in the respective tier's draw. Exceeding the requirements does not award participants an extra chance.
 - While participants may qualify for more than one tier, they are only entitled to win one prize in the contest, whichever is the higher amount.e.g. a participant who qualifies for Tier 3 naturally meets the requirements of Tier 1 and 2, and thus, automatically qualifies for all 3 tiers but can only win once.
- Winner Notification
 - Winners of each tier's draw will be picked randomly.
