## By - Laws

### BALANGODA URBAN COUNCIL

#### By-Laws

BY virtue of powers vested under Sections 153 and 154 of the Urban Council Ordinance which come under power of authority of 255, I, the Governor of Sabaragamuwa Province declare that the following By-law adopted by the Balangoda Urban Council has been approved by me as per the powers vested in me in Section 154 of the Urban Council Ordinance.

#### MAINTENANCE, FORMALIZATION, SUPERVISION, CONTROLLING AND ADMINISTRATION OF THE WEEKLY FAIR OF THE BALANGODA URBAN COUNCIL

Power Vested in the Council Legal Provision	1. It is imposed as per the power vested in the Balangoda, Urban Council by Section 157 which should be read along with sub-section 153 (1) of Chapter 255 of the Urban Council Ordinance No. 61 of 1939.
Subject of the by law & aims Name	2. Maintenance, formalization, supervision, controlling and administrative of the Balangoda Urban Council. 3. This by law is named as the By-Law of Maintenance, formalization, supervision, controlling and administrative of the Balangoda Urban Council.
Tasks to be performed	4. All the buildings in the weekly fair should have been constructed from bricks, stones or permanent building material and the floor of every weekly fair building should have been constructed with concrete and the floor of the house should have been constructed at an elevation of minimum one feet from the ground level.

5. The roof should have been constructed with any permanent roofing methodology. Every roof should have been made for draining rain water.
6. Except on a special occasion, space between two lines of business rooms within the building should be of 02m. wide and the pedestrian portion should be built with permanent building material to suit the travelling of the consumers. The rain water should be drained without interrupting the intercourse of passengers thereby.
7. Every stall should consist of metal sheet on a bund from bricks, cement blocks, or laterite. However, when it is made of concrete Sheet that sheet should be plastered burnished with cement or fixed with floor tiles. When there is no necessity to do so the lines dividing each part should be marked in white.
8. An adequate number of Latrines and urinals should be made available separately for males and females and citizens of special necessities. The floor should be ceramic tiles and the walls of such latrines should be ceramic tiled at a height of one metro.
9. It is legal to maintain either a restaurant or tea or coffee shop made in accordance with a plan approved by the council with in the premises of the weekly fair.
10. It is the task of the council to make a supply of electricity for the use of every Sales Centre of the weekly fair on necessity.
11. Having taken the situations in sales Centres of the weekly fair into consideration sales of meat, fish, dried fish, vegetables, fruits, provisions and other sales items there should be separate apartments by the Balangoda Urban Council. It is the task of the Urban Council to display the fabrication at the entrance of the weekly fair.
12. Wastes generating within the premises.
  - i. Bio waste matter
  - ii. Glasses
  - iii. Paper and materials using paper.
  - iv. Polythine and plastic or materials of plastic or polythine or plastic and regiform.
  - v. Iron or other metal or iron or other parts mixed with metal.
  - vi. Dangerous Waste matter.
    - Buggies or vessels or tanks that can be collected separately should be kept in a separate place the buggies or vessels or tanks made for putting bio waste matter should be well closed so that mice, flies, any insects, or birds cannot enter or there should be a proper way of taking away the waste generated in the premises.
13. Any space meant for sales purpose in the weekly fair should be specifically marked by the council.
14. In case of ending the business by the sellers of the weekly fair in the business premises or the seal should be washed and cleaned occasionally.
15. On an occasion where the sales are over in the weekly fair and completely closed and on every occasion any sales stall is on closed and going away all the electric lamps and electric equipment should be made inactive.

Tasks that should be done

16. any sales material or good or any sales equipment and any other things that is brought to the weekly fair, such material or good should not be left away from the limits mentioned in section 07 above or allowed to do so, except on an occasion when such material is taken away.
17. Selling should not be done in any place other than in the premises permitted for transaction of business and in the places where mobile sale is permitted and or any action should be done so as to disturb the pedestrians.
18. Any individual should not do any cooking in any place in the weekly fair other than in a place mentioned in the 09th by-law.
19. In any weekly fair belonging to the Balangoda Urban Council,
  - I. Behaving having drugs or liquor or using insane words or begging,
  - II. Staying in the premises after the day's work is over,
  - III. Destroying, damaging or disfiguring any building, construction or fixation or any vase of flowers grown for beau trifurcation or kept or any name board or any material.
  - IV. impurifying wasting or letting wasting, wasting in any manner, bathing from that water, washing animals and washing vegetable in any place other than in the place meant for washing vegetables and fruits.
  - V. Keeping goods in a way un accessible to the main key board or damaging the main board,
  - VI. Fraudulently obtaining a water connection from the main pipe line which is lain within the building or from any other pipe line,
  - VII. Felling and displaying vegetables and meat or fish or making arrangement to do so in any place other than the places reserved for such purposes,
  - VIII. Bringing foot bicycles or motor cycles or motor vehicles to any place other than the places prepared for them within the weekly fair. Premises.
20. Any person who is suffering from infections, tactual skin disease or who is suffering from such a disease unless the period of such in fection propagation is over, should not be allowed to do any mode transaction or occupying and exploiting to do so should not be allowed.
21. Any person unless he/ she is in well washed clean dress should not be allowed to do any transaction or occupying to do so should not be done.
22. When a market place is reserved for selling a particular kind of goods or material by the Balangoda Urban Council no other kind of goods or material should be sold or displayed to do so by any person.
23. Any person should not tell, display for selling any meat of an animal unless it is duly permitted under the provisions of the Cattle Slaughter Ordinance.
24. In case of any order published in the *Gazette* by the due authority as per the power given in section 17 of the Cattle Slaughter Ordinance banning to slaughter animals in any date selling in any butchary keeping meat or displaying for selling or storing should not be done.
25. Bringing or allowing to bring any dog or cat or any kind of animal or bird into the weekly fair premises should not be done by any person. This order should not be understood as an order not to bring as official police dog into the premises by a police officer for any investigation matter.

26. Any person who has obtained any sales place in a weekly fair to use or maintain should not sell or display or use it for any other purpose on insufficient or such a place or even a portion of it to any other person.
27. No any person should make any construction, fixation or covering so as to alter the due plan or damage that design or make any alteration of a plan designed in the premises of the weekly fair unless the authority is given on a prior decision by the Balangoda Urban Council.
28. Without getting permission in writing from the Chairman or authorized officer no covering, drawing a curtain or permanent alteration should be done near or in the premises or space given to a person.
29. Without permission from the Chariman or an authorized officer, any box, table, chair or any such good that is not the property of the Balangoda Urban Council should not be kept there or making huts and fixing other equipment should not be done.
30. Obtaining an electric supply or water supply from any electric current or common water tap which is used for public consumption in the weekly fair premises, should not be done or should not be allowed to do.
31. Except that it is legal for the chairman of the Balangoda Urban Council or an authorized officer, to obtain a sample of any food item which has been kept for selling or displaying for selling or stored in a weekly fair, refusal of such buying by any person or interrupting for it should not be done.
32. Palm reading, making suggestions to read palms or making life predictions should not be done.
33. Any kind of drugs or medicine or any chemical material belonging to dangerous, unpleasant or danger causing type should not be sold, propagated for selling or kept for selling.
34. Propagating or lecturing or making public speeches regarding any religion should not be done near or in the premises of the weekly fair.
35. Selling intoxicant drugs or keeping them for selling or holding propaganda for it or distributing notice bills in the weekly fair ground or premises should not be done.
36. Making propaganda or sales activities in the weekly ground or premises or for business transactions or for any other task by making use of loud speaker sets or modern high technological sound waves pollyting the sound should not be done.
37. Even though it is mentioned so in the above by - law of 36, the Chairman or the authorized officer has the ability to use a loud speaker set or modern hight technological sound waves for making the public aware of any urgent, compulsory incident which affects the public.
38. When orders are given to get out of the weekly fair premises by the officers in the Council coming for the duty to collect fees in the weekly fair.
39. When orders are given to get out of the weekly fair premises by the officer in charge of the weekly fair or Grama Niladhari or police officer or any other person taking action authorized by the Chairman no one should stay there for making disputes with him without being able to give a satisfactory answer, or loitering there without reason should not be done.
40. Each and every vegetable, fruit, yam or other food items should not be unhealthy for the public.

Duties of the local government institute

41. Observing the following provisions of the by-Law regarding any weekly fair conducted by the Council should be done by the Balangoda Urban Council.
42. It is the task of the Balangoda Urban Council to clean completely the premises prior to the date of holding the weekly fair and to clean completely once again at the end of the day the weekly fair is held.
43. It is the task of the Balangoda Urban Council to clean every latrine and urinal by washing using anti biotic or least once a day on which every weekly fair is held and to clean by washing every drain meant for flowing water once a day on which the weekly fair is held.
44. The wastes collected to every buggy, vessel or tank made in accordance with the provisions in section 12 should be made removed from the place or least once a day or more on necessity by the Balangoda Urban Council.
45. The days and times that the weekly fair conducted by the Balangoda Urban Council can be decided from time to time by the council. It is the duty of the Chairman to make such day and times decided by the council known through notice or notices in three languages by displaying it/ them in a publicly noticeable place at the entrance to the weekly fair.
46. Maintenance of peace within the fair premises should be done by an officer/ officers in service appointed by the council.
47. Every person who comes to the fair for buying or selling should obey any legal order given by an official in the council, or a police officer in order to settle a dispute or maintain peace.

Leaving chargers.

48. Any person engaged in selling in the weekly fair places should not engage in selling activities unless he/ she has obtained a duly paid permit prepared by the Balangoda Urban Council in accordance with subsection of this By-Law. It is legal to impose such charges, changing them from time to time or amending them.
49. Any authorized officer from the secretary can be deployed to issue a permit to any person who wants to use or handle the sales places in the weekly fair and collect money for such permits.
50. It is the duty of the money collector not to collect money in the weekly fair without issuing a permit and credit the money duly collected to the Urban Council fund as ordered by the Council.
51. In case of any inability to deploy an authorized officer from the secretary, for issuing a permit and collecting money for it as per the way mentioned in by-Law 48 the Balangoda Urban Council has the power to deploy a person selected through public tender calling for that purpose.
52. Deploying a tender person selected under by-Law 51 for such a task will be valid only for one year and a tender person should be selected for the successive year through tender calling. Although it is so this does not mean that liability for forwarding a tender application for tender person selected in the previous year and being his tender application accepted by the Council for the successive year is restricted by this by-Law.
53. Under the provision of By-Law 48 any tax collector should not collect excessive charges exceeding the charges decided by the Balangoda Urban Council for the use of sales places in any weekly fair.
54. The Council should take steps to come to a due agreement with the tender person who will be selected to collect charges in a weekly fair.

55. Any person who has got a permit for using or handling any sales place in the weekly fair, should not negotiate it or should not do selling in any premises other than the premises mentioned for it and on occasion where the Chairman or the authorized officer is satisfied at to the fact that he/she has done so the Chairman or the authorized officer should have power to refer him/ her to the due place or to debar him/ her from sales activities or cancel the permit.
56. Any dispute among the valid permit holders or the servants under the power such permit holders, and between permit holders and the public regarding the use of the weekly fair should be settled by the Chairman or any other officer authorized by the Chairman.
57. If any food item displayed for selling is found unsuitable for food by the Medical Officer of Health or Public Health Inspector or any Health Inspector authorized by the Chairman, it is lawful to examine that food item and ban it. Pracesses of inquiries
58. On an occasion where any food item is found unsuitable for public consumption that whole lot or those whole lots should be banned and forwarded to the Public Health Inspector by an authorized officer.
59. No compensation will be paid when destroying such a lot of food items by the Public Health Inspector in accordance with the by-Law 58 above.
60. Any under can be produced to a due court of law and given a penalty for keeping food items for selling which is unsuitable for the Public consumption.
61. The council has the authority to decide whether to allow a person found guilty at a court of law as per by-Law 59 above to enter the fair premises for selling again or debar him from coming to the premises.
62. If any relief is expected by any person regarding the weekly fair, the Balangoda Urban Council has the ability to make a decision on that relief application done in writing.
63. The entire supervision should be done by the Balangoda Urban Council.
64. It is an offence to break or neglect or violate any By-Law, or sub, By-Law or several by-Laws or all. Violation of by-law
65. Violation of any section included in this by-Law is an offence. If any person is convicted of any offence by an authorized court of law, he/she is liable for a fine mentioned under section 153 (2) of chapter 255 of the Urban Council ordinance of No. 61 of 1939 and if that offence is continued to do he/ she is liable for an additional fine or each day of such continuation even after handing over a written notice by the Chairman of the Urban Council or a secretary or any officer authorized by him, according to section 153 (2) of Chapter 255 of the Urban Council Ordinance No. 61 of 1939. Penalties
66. In case of any discrepancy among the copies in three language Sinhala, Tamil and English the idea mentioned in the copy in Sinhala should be compellable.
67. The Balangoda Urban Council has the power to amend or continue any by-Law or sub by - Law or several by-Laws or the entire series of by-Law of this series of by-Laws.

Definitions

- 68. Unless otherwise, any definition is needed regarding the words of this by-Law;
  - (i) "The Council" means the Urban Council of Balangoda.
  - (ii) "Chairman" means the Chairman of the Balangoda Urban Council.
  - (iii) "Secretary" means the secretary of the Balangoda Urban Council.
  - (iv) "Officer" means an officer or a servant deployed by the Chairman or this secretary of the Balangoda Urban Council.
  - (v) "Weekly fair" means the weekly fair conducted by the Balangoda Urban Council.
  - (vi) "Consumer" means male or female parties who come to buy the goods and materials kept for sale.
  - (vii) "Any person" means all the sellers, consumers, officers, males and females and clergy who comes to the weekly fair.
