THE PILGRIMAGES ORDINANCE (CHAPTER 175)

Esala Maha Perahera of the Historical Sankhapala Raja Maha Viharaya - 2021

PUBLIC attention is drawn to the Regulations of the pilgrims in the *Gazette Extra Ordinary* No. 2153/15 dated 12.12.2019 published under the Pilgrimages Ordinance Chapter 175. Following facts are notified with regard to such regulations.

1. Duration of the Perahera

- The kap planting for the Esala Perahera 2021 to be taken place at the auspicious time on 07.10.2020,
- All night Pirith Chanting on 15.10.2021 and alms giving on the following day.
- Kumbal Perahera on 16.10.2021,
- Salu Perahera on 17.10.2021,
- Randoli Perahera on 18.10.2021,
- Ginisilu Perahera ceremony on 19.10.2021,
- Maha Perahera on 20.10.2021,

- Water Cutting ceremony and Gammadu ritual on 21.10.2021,
- The Esala perahera will end by alms giving to the God at dawn on 22.10.2021.

2. The Camp Area:-

• The area for the Esala Festival to be conducted shall be the premises bounded to the North by the Sankhapala peak, to the South by Rakwana river, to the East by Perahera Mawatha and to the West by Perahera Mawatha.

3. Vehicles

- 3.1 No vehicle, including motor vehicles, bicycles, and carts shall park or enter any place or festival premises except the area reserved for parking without my permission or such permission given by an authorized officer.
- 3.2 Entering vehicles to the sacred area through the gateway erected facing to the Ratnapura -Embilipitiya main road is strictly prohibited.

4. Construction of Buildings

- 4.1 No person shall construct or build any shelter or structure whether temporary or permanent or add a new part to such building which is already exist within the camp area during the period of 24th October, 2021 to 22nd October, 2021, without my written permission or such permission obtained from an authorized officer.
- 4.2 Whereas, it shall be permitted to enter any land or place situated in the camp area in order to implement any regulation, out of the regulations imposed by me or any authorized officer or to erect a pillar or to conduct a construction or a building on any land or place within the camp area in order to display any notice or signboard.

5. Health

- 5.1 No person suffering from infectious diseases or communicable diseases shall enter the camp area and it should be thoroughly ensured to follow the current health guidelines.
- 5.2 Participating of the devotees shall be permitted only on the Maha Perahera day and such participation shall be according to health guidelines providing them required health facilities.

- 5.3 Other Perahera days shall be conducted limited to the rituals and without participation of the devotees.
- 5.4 The number of participants of the dance troupes shall be limited and maintaining details of such members of each dance troupe, checking them before the perahera, following health guidelines when providing accommodation shall be performed.
- 5.5 Food provided for the participants of the Perahera shall be subject to the supervision of the Medical Officer of Health.
- 5.6 I entrust the Office of the Medical officer of Health - Udawalawa, the District Hospital, Embilipitiya, the Base Hospital - Udawalawa and the Provincial Directorate of Health Services to provide health services before and during the perahera festival.

6. Trading

- 6.1 Sale of tickets and flags, collecting money for contribution or any other purpose shall not be permitted in the camp area without my permission or such permission of any authorized officer and sale and use of tobacco products and all narcotics within and surrounding the camp area are strictly prohibited.
- 6.2 Every sales outlet of flowers and Pooja trays in the camp area shall be kept closed from 5.00 p.m. until the Perahera ends on which the Perahera to be conducted.

7. Beggars

• No person shall solicit alms within the camp area except the places reserved outside the camp area and no person shall distribute any alms to beggars within the camp area except the aforesaid places.

8. Electricity

• I entrust the Ceylon Electricity Board Embilipitiya to provide lighting to the temple premises and along the perahera rout, street lighting and to fix extra street lights.

9. Water

• I entrust the National Water Supply and Drainage Board Udawalawa, the Embilipitiya Pradeshiya Sabha and The Divisional Secretariat Embilipitiya to provide water facilities to the devotees by placing extra water tanks and supplying water for the bowsers.

10. Security

• I entrust the security forces and the police all security matters, handling traffic without obstructing the Perahera and the devotees.

11. Accommodations

 Kolambageara Maha Vidyalaya and Sankhapala Gunarathana Vidyalaya are reserved for providing accommodation for the dance troupes and such arrangements following the health guidelines are assigned to the Principals of the respective schools. Aforesaid regulations from No. 03 to 11 shall be valid until the end of the Perahera Festival.
