The candidate who would obtain highest marks at the structured interview will be appointed to the vacancy. Marking scheme of the interview is attached as annex 01.

The decision of the Honorable Governor shall be final regarding this recruitment.

#### 4. Conditions of the Employment and Service:

This appointment shall be subjected to general rules set out in the new Procedural rules of the Public Service Commission, Establishment Code, Financial Regulations and the relevant service minute and the conditions mentioned in the letter of appointment issued at the time of appointment to the relevant post and shall be subjected to regulations of the Provincial Council/ Statutes/ Financial Regulations issued by the Honorable Governor from time to time.

Selected candidates should be agreeable to serve in the Western Provincial Council for a period of 03 years.
