Age: The candidate should be not less than 35 years and not more than 55 years. The upper age limit will not apply to internal candidates.

Nature of Functions

The Director General (CEO) is accountable and responsible for all activities, and administrative and financial affairs of the Institute who under the general direction and control of the Board of Directors, exercise, perform and discharge powers, functions and duties of the Board as may be delegated by the Board and provide leadership and encouragement to the staff of the Institute, for excelling in official achievements and generation and transfer of technology.

Recruitment Procedure:

A structured interview conducted by a panel appointed by the appointing authority.

Appointments will be made purely in the order of merit at the interview.

General Conditions
