Construction of Solid Waste Disposal Facility Project

The Government of Sri Lanka (GoSL) recognized the immediate need for an integrated solid waste management system to ensure the proper handling of wastes in the country. In 2007, the Ministry of Environment formulated the National Policy on Solid Waste Management. In the way forward, the government has now embarked upon providing solutions for final disposal of residual waste resulting from the treatment of municipal solid waste in the island's growing areas with the expertise drawn from Government of Republic of Korea.

Accordingly, four sanitary landfills are planned to be built in four cities in the country (Panadura, Anuradapura, Udunuwara, and Hikkaduwa) with the technical and financial support from the Government of Republic of Korea under the Economic Development Corporation Fund (EDCF) administered by Eximbank, Republic of Korea.

The project will also provide other infrastructure facilities, equipment & machineries required and training and capacity building for stakeholders to ensure sustainability of the operation of the landfills. The CEA wishes to invite applications from qualified and experienced candidates who are citizens of Sri Lanka, for the following Posts. Appointments will be initially for a period of one year and further extendable depending on the performance.

1. Deputy Manager – Land & Legal (01 Post)

At least 06 years post qualifying experience in the relevant field.

Or

- An officer of the Government All island Services Class III/II or above or similar status in the relevant field.

And

At least 05 years experience in Class II/III post.

Age : Should be below 65 years

3. Draftsman (01 Post)

Qualifications and Experience:

- A Bachelor's Degree in the relevant field which is recognized by the University Grants Commission.

Or

- Having obtained a certificate of proficiency not below than the National Vocational Qualifications. Level 7 issued by a Technical/Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to Technical field.

And

At least 01 years experience in the required area of specialization.

Or

- Having obtained a certificate of proficiency not below than the National Vocational Qualification. Level 6 issued by a Technical/Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to Technical field.

And

At least 06 years experience in the required area of specialization.

Or

- Having obtained a certificate of proficiency not below than the National Vocational Qualifications. Level 5 issued by a Technical/Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to Technical field.

And

At least 11 years experience in the required area of specialization

Age : Should be below 65 years
