



POST OF CHIEF MANAGER (INFORMATION SYSTEMS SECURITY) GRADE I

Applications are invited from eligible candidates who possess the under-mentioned qualifications and experience for the post of Chief Manager (Information Systems Security) – Grade I, at the National Savings Bank.

Eligibility Requirements:

- (1) Candidates should be citizens of Sri Lanka.
- (2) Educational/Professional Qualifications:
 - BSc in Information Technology from a recognized university.
 - Certification in CISM / CISSP or similar certification would be advantageous.
 - Preference would be given to a Masters in Information Systems Security.
 - Professional qualifications in the domains of Network/Server/Firewall.
- (3) Experience:
 - Minimum 8-10 years' experience as an Information Systems Professional.
 - Minimum of 4 years' experience as an Information Security Manager or similar position in a reputed organization (preferably financial).
 - Should have managed/supervised a technical/operational team in implementing Information Systems Security policies and procedures within the IT department and across other departments of the organization.
 - Experience with heterogeneous Windows and UNIX environments and other IS security components such as firewalls, network management systems, log monitoring and log correlation systems etc.
- (4) Age Limit:
Below 45 years.

Key Responsibilities:

- Ensure the confidentiality, integrity and availability of systems and networks through planning, analysis, development, implementation, maintenance and enhancement of information security programs and policies.
- Be responsible for the coordination, selection and / or development and implementation of enterprise-wide security measures and controls to ensure the protection of the bank's information assets.
- Lead preparation and implementation of necessary IS policies, procedures, guidelines and standards as per the regulatory and compliance requirements.
- Provide IT security guidance to the bank using a risk-based approach.
- Lead activities relating to Business Continuity Management System and IT Disaster Recover procedures.
- Co-ordination with external consultants who provide periodic IS Security Assessments to the bank's IT Infrastructure.
