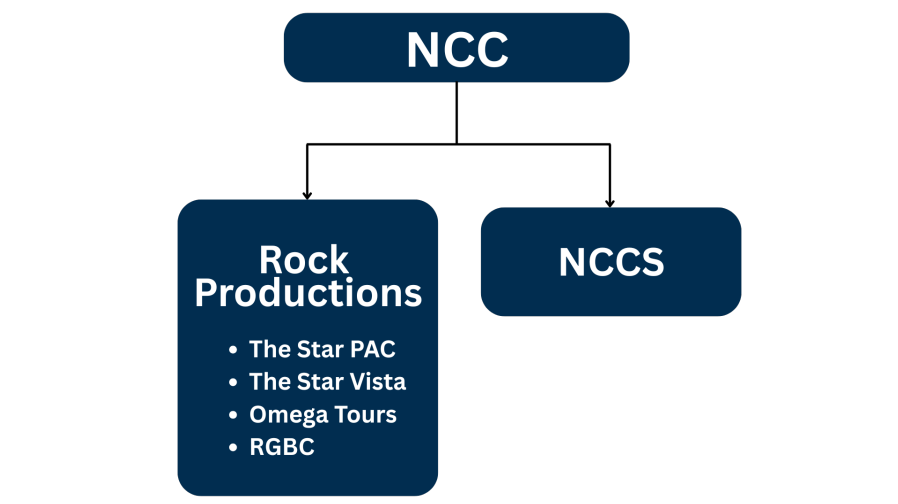
## Overview of Our Group Structure

The church currently owns Rock Productions Pte Ltd (Rock Productions), which in turn owns the following entities:

- The Star Performing Arts Centre (The Star PAC);
- The Star Vista;
- Omega Tours & Travel Pte. Ltd. (Omega Tours); and
- Rock Gifts And Book Centre (RGBC).

In 2023, the church also established a social service arm, New Creation Community Services Ltd. (NCCS) to deepen our impact in the community.

## More About Our Entities



### **ROCK PRODUCTIONS PTE LTD**

**Established: 1998**

Rock Productions was established as a venue provider to secure a more permanent space for our growing congregation.

Through it, we leased and operated Rock Auditorium in Suntec City Mall, which served as our worship venue from 1999 to 2012. To support additional needs of the church, Omega Tours was established in 2004 to organise Bible land tours internally, instead of relying on external travel agencies, while RGBC was opened to serve as a retail frontage at Suntec, offering Christian resources.

In 2007, Rock Productions successfully tendered to develop, lease and operate The Star—a civic, cultural, and retail hub—which houses both The Star PAC and The Star Vista. We started holding our services at The Star PAC in December 2012 and became its anchor tenant. In 2019, Rock Productions acquired The Star Vista, the adjoining retail mall, to safeguard the church's long-term interests and preserve the experience for our congregation and visitors.

### **ROCK GIFTS AND BOOK CENTRE**

**Registered: 1998**

To align with other shops operating in Suntec City Mall, we were required to have a retail frontage for Rock Auditorium. Hence, RGBC opened a storefront at Suntec City Mall, which retails Christian resources and paraphernalia. The opening of RGBC is also consistent with our desire to make Christian resources available to our congregation. RGBC is a business wholly owned by Rock Productions.



## **OMEGA TOURS & TRAVEL PTE. LTD.**

**Established: 2004**

Omega Tours was established as a travel agency wholly owned by Rock Productions. It was set up to enable our church to organise Bible land tours for our congregation, helping them gain a deeper understanding of the Scriptures. Prior to this, such tours were arranged through external travel agencies.

## **THE STAR PERFORMING ARTS CENTRE**

**Officially Opened: 2012**

The civic and cultural zone of The Star, spanning levels 3 to 11, is known as The Star PAC. It includes a 5,000-seat theatre, and serves as a place of worship on service days for NCC, its anchor tenant.

The Star PAC is also available for hiring by impresarios, concert organisers, institutions and commercial organisations when not in use by the church. It has since become a venue of choice for mid-sized concerts, corporate events, and performances by regional and international artistes in Singapore.

## **THE STAR VISTA**

**Acquired: 2019**

Rock Productions acquired The Star Vista, the retail zone of The Star spanning basement 4 to level 2, after its then-owner CapitaLand initiated a sale. As the mall and The Star PAC are closely linked, the acquisition safeguarded the church's long-term interest and preserved the good experience for our congregation and visitors who come to The Star PAC.

**NEW CREATION COMMUNITY SERVICES LTD.**  
**Established: 2023**

Since its founding in 1984, NCC has been actively doing good works to glorify God and making a difference in people's lives, regardless of race, language, and religion, through practical acts of kindness.

As part of our church's continued efforts to deepen our community work and expand our reach, NCCS was established as our official social service arm in 2023. It was granted charity status in Singapore on 15 September 2025. NCCS continues to carry the heart and vision of the church and our desire to love people, one at a time.
