



## WEBSITE TERMS OF USE

### 1 Terms of Service

Please read the terms of service (**Terms of Service**) set forth below, as they apply to your access and use of our services, including our various websites, APIs, email notifications, applications buttons and widgets (**Services**), and any information, text, graphics, photos or other materials uploaded, downloaded or appearing on the Services (collectively referred to as **Content**). Your access to and use of the Services signifies your acceptance of these Terms of Service and agreement to be bound by them and any and all other applicable terms referenced herein absolutely.

### 2 Other applicable terms

2.1 These Terms of Service refer to the additional terms in our Privacy Policy Statement, which also apply to your use of our Services:

2.2 Our Privacy Policy Statement sets out the terms on which we process any personal data we collect from you, or that you provide to us. By using our Services, you consent to such processing and you warrant that all data provided by you is accurate. You understand that through your use of the Services you consent to the collection and use (as set forth in the Privacy Policy) of this information, including the transfer of this information both within and outside of Hong Kong for storage, processing and use by us. As part of providing you the Services, we may need to provide you with certain communications, such as service announcements and administrative messages. These communications are considered part of the Services and your **www.OKiBook.com** account, which you may not be able to opt-out from receiving.

### 3 Information about us

The Services are provided and operated by **OKiBOOK Limited**. We are a limited liability company registered in Hong Kong with registered number two million three hundred thirty-nine thousand nine hundred and ninety-six (2339996) and have our registered office at Unit D, 58/F, Block 5, 12 Tung Chung Waterfront Road, Tung Chung, Hong Kong SAR.

### 4 Changes of terms

We may amend the Terms of Service from time to time at our sole discretion without notice or liability to you. By continuing to use the Services following such amendments to the Terms of Service, you agree to be bound by such amendments.

### 5 Changes to our Services

5.1 The Services that we provide are always evolving and the form and nature of the Services that we provide may change from time to time without prior notice to you. In addition, we may stop (permanently or temporarily) providing the Services (or any features within the

Services) to you or to users generally and not be able to provide you with prior notice. We also retain the right to create limits on use and storage at our sole discretion at any time and without prior notice to you

- 5.2 We make no representations, warranties or guarantees, whether express or implied, that our Services or any content on our site is accurate, complete or up-to-date.

## 6 **Accessing our Services**

- 6.1 Our Services are made available free of charge.

- 6.2 We do not guarantee that our Services, or any content, will always be available or be uninterrupted. Access to our Services is permitted on a temporary basis. We may suspend, withdraw, discontinue or change all or any part of our Services without notice. We will not be liable to you if for any reason our Services are unavailable at any time or for any period.

- 7.1 OKiBook website allows users to search for and book a restaurant table online in real time.

- 7.2 OKiBook website allows users to benefit from promotions or special offers from the restaurants listed on the site, provided that the reservations are made using the dedicated reservation procedure in OKiBook website's reservation module. Not all restaurants have promotions or special offers. The conditions of validity for these promotions are explained on OKiBook website.

- 7.3 By setting up an account on OKiBook website, users can make reservations without having to re-enter their contact details, and, thanks to OKiBook's business agreements, users can benefit from exclusive offers in selected restaurants.

- 7.4 Users are responsible for making any checks that may seem necessary or prudent before making a reservation at one of the restaurants listed on OKiBook website. OKiBook does not guarantee in any way the products, services and/or business practices of third parties listed on its site. Therefore, OKiBook cannot guarantee that users will be satisfied with the products, services and/or business practices to which they are exposed as a result of making a reservation on OKiBook website.

## 8 **Your account and password**

- 8.1 You are responsible for safeguarding the password that you use to access the Services and for any activities or actions under your password. We encourage you to use "strong" passwords (passwords that use a combination of upper and lower case letters, numbers and symbols) with your account. You must treat such information as confidential. You must not disclose it to any third party. **OKiBOOK Limited** cannot and will not be liable for any loss or damage arising from your failure to comply with the above.

8.2 We have the right to disable any password, whether chosen by you or allocated by us, at any time, if in our reasonable opinion you have failed to comply with any of the provisions of these Terms of Service.

These Terms of Service shall be governed by the laws of the Hong Kong Special Administrative Region. You agree to submit to the exclusive jurisdiction of the Hong Kong courts.

## 24 **Languages**

In case of discrepancies between the English and Chinese language versions of these Terms of Service and contents of this site, the English version shall prevail.
