Amended ARTICLES OF INCORPORATION

OF

PARAMOUNT LIFE & GENERAL INSURANCE CORPORATION

[As Amended on 23 September 2014]

KNOW ALL MEN BY THESE PRESENTS:

That we, all of whom are of legal age and residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the Philippines.

AND WE HEREBY CERTIFY:

FIRST. - That the name of said corporation shall be "PARAMOUNT LIFE & GENERAL INSURANCE CORPORATION". [As amended on 16 September 2002, 07 December 2001, 18 February 1997, and 26 February 1993]

SECOND. - That the purposes for which such corporation is formed are:

PRIMARY PURPOSE

To carry on and engage in the business of insurance, reinsurance, bonding, fidelity and guaranty in any and all branches including life and non-life insurance, health and medical insurance, accident insurance and other insurance and other businesses permitted to be conducted by a life and/or non-life insurance company, and to act as agent of other insurance including life and to do and perform all such acts and things as may be necessary, expedient or convenient to carry out the purposes intended by the organization of this corporation and not inconsistent with law.

SECONDARY PURPOSES

To lend money subject to the requirements of law.

To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or corporation carrying on any business which the Corporation is authorized to carry on and to possess property.

Subject to legal restrictions and to the rules and regulations promulgated by the Insurance Commissioner, to acquire by purchase, or otherwise, and to invest in, hold, sell, or otherwise dispose of the stock or bonds, or any interest in either, or any obligations or evidences of indebtedness, of any corporation or corporations, domestic or foreign, or the bonds or other obligations or evidences of indebtedness, of any person, firm or corporation, and while the owner of such stocks, bonds or

interests therein, or other obligations or evidences of indebtedness, to, exercise all the rights, powers and privileges of ownership, including the rights to vote thereon or consent in respect thereof for any and all purposes.

To purchase or otherwise acquire, sell, lease, convey, mortgage, encumber, and otherwise deal with any property or interest therein, or easement, right or privilege over or in respect of any property, real or personal, as may now or hereafter be permitted by law.

To enter into, make, perform, and carry out contracts of every sort and kind with any person, firm, association, corporation, private, public or municipal, or body government or politic.

To do all acts necessary or convenient for carrying on or transacting in any foreign country, state, dominion, dependency, colony, protectorate or possession, any business or act of the Corporation and to procure the registration or other legal recognition of the corporation in any such foreign country, state, dominion, colony, protectorate or possession.

To do all such other things as are incidental or conducive to the attainment of the above objects.

To do and perform any and all of the acts and things and to exercise all of the general powers conferred by law upon corporations similarly organized and usually and ordinarily incidental to corporations of like nature and kind.

THIRD. - The principal office of the Corporation is at the 14th and 15th Floors, Sage House, 110 V.A. Rufino Street, Legaspi Village, Makati City, Philippines. [As amended on 23 September 2014]

FOURTH. - That the term for which the Corporation is to exist is extended from 23 April 2009 until 22 April 2059. [As amended on 06 April 2006]

The sale or issuance of shares shall be subject to the Shareholders' Agreement dated 1 February 2005, the Subscription Agreement dated 1 February 2005, the Share Retention Agreement dated 27 October 2004, and the Put Option Agreement dated 27 October 2004, as may be amended from time to time, all of which documents shall be on file with the Corporate Secretary of the Corporation. [As amended on 07 April 2005]

ELEVENTH. - That Buenaventura B. Loberiza has been elected by the subscribers as Treasurer of the Corporation to act as such until his successor is duly elected and qualified in accordance with the By-Laws, and that as such Treasurer he has been authorized to receive for the corporation and to receipt in its name for all subscriptions paid in by said subscribers.
