For participants who achieve Director rank for the first time since signing up with Unicity are eligible for 1 free package as long as they meet the following criteria:

- Participants must achieve Director Rank for their first time during qualification period and must have 1500 TV in that month.
- In order for participants to be eligible for this, they did not qualify for any previous trip with Unicity.
- For the participants who have achieved Director Rank and 1500 TV for the first time, the participants must achieve at least Executive Manager rank for 1 month.
- During the qualification period, the participants must maintain personal volume at least 250 Hong Kong PV and no product return.
- Participants must maintain "Active Status" (100 Hong Kong PV) after the qualification ends until the travel date.

Terms & Conditions

- For BAs who join Unicity before March 1st, 2020; Rank Advancement and/or Rank Maintenance Point will be based on your highest rank from Nov 2019 – Feb 2020.
- For BAs who join Unicity from Mar 2020 to Jun 2020; Rank Advancement and/or Rank Maintenance Point will be based on your 1st month Rank that you join.
- During the qualification period, if your rank is higher than the base rank, that rank will be the new base rank for following months.
- *Points from maintaining new rank will be given once a new rank is maintained during the qualification period.
- For Director Ranks and above, BAs must maintain at least 1500 TV in order to accumulate points for that particular month.
- If a few distributors achieve new rank of Executive Manager stacked in the same line, Executive Manager Rank at the bottom of the organization will get points from Rank Advancement. The uplines who achieve Executive Manager Rank will get 3 points only unless approval has been given by Unicity for Rank Advancement Point for the uplines in the 2nd and 3rd level who have at least 2500 OV on the 2nd leg (non-compressed).
- All BAs have to achieve the rank of Executive Manager or higher for at least 2 commission months during the qualification period.
- All BAs must maintain at least 250 Hong Kong PV, starting from the 1st month that BAs accumulate points until the end of qualification period.
- BAs must maintain "Active Status" (100 Hong Kong PV) after the qualification ends until the trip period.
- BAs who qualify must attend the trip **PERSONALLY**. Trip points are non-transferable or exchangeable.
- BAs are responsible for applying and obtaining any necessary VISA/ travel documents including associated fee. Unicity will not be responsible for any unsuccessful VISA/travel documents application.
