PROFILE

Ashley Burns, SC has been practicing law in the field of commercial dispute resolution for over 40 years. He first qualified as a solicitor in England in 1972 and was admitted as a solicitor in Hong Kong in 1977. He was a partner of Johnson Stokes & Master (now known as Mayer Brown) from 1981 to 1987, the managing partner of Turner Kenneth Brown's Hong Kong office from 1987 to 1993 and then managing partner of the Hong Kong office of Wilde Sapte (subsequently known as Denton Wilde Sapte and now known as SNR Denton) from 1993 to 1996. He was called to the Hong Kong Bar in 1996 and took Silk in 2007.

Ashley Burns has a broad predominantly commercial practice with an emphasis on employment and partnership related matters. He regularly appears in the High Court – in the Court of First Instance; in the Court of Appeal and also in the Court of Final Appeal. He has also been involved in a number of arbitrations (both as arbitrator and advocate) and is available for both arbitration and mediation work.
