## SELECTED CASES

- *Quaestus Capital Pte Ltd v Everton Associates Limited* [2021] HKCFI 1367: appeared on behalf of the 2nd Defendant to challenge the jurisdiction of the Hong Kong courts over various tort claims on the basis of an exclusive jurisdiction clause in favour of the courts in London (led by Jin Pao SC).
