



FairPrice Fortune Draw 2019 | FAQ

Q1. Who can enter the FairPrice Fortune Draw?

- A1. This Draw is open to all Singapore citizens and permanent residents, aged 18 years and above, except for employees of NTUC Fairprice Co-operative Limited, Trans Eurokars Pte Ltd and their advertising, creative and promotion agencies, as well as immediate family members.

Q2. How and when can I enter the FairPrice Fortune Draw?

- A2. Every \$30 spend at FairPrice, FairPrice Finest, FairPrice Xtra, Warehouse Club and Unity stores (except Unity store at Changi Airport Terminal 3) between 27 Dec 2018 and 20 Feb 2019 will qualify you for one chance for the lucky draw from 27 Dec 2018 to 20 Feb 2019. For FairPrice On, every \$30 spend during the qualifying period from 27 Dec 2018 to 13 Feb 2019 entitles you to one chance for the draw. Lucky draw stub(s) will not be issued for purchases made by Corporate customers and/or Shop & Donate orders.

Q3. How does the FairPrice Fortune Draw work?

- A3. You will receive one lucky draw stub for every \$30 spend during the lucky draw period. Fill in your name (as per NRIC), NRIC number (only the last 3 digits and alphabet), mailing address, email address (FairPrice On customers only), contact number, invoice number (FairPrice On customers only) on the lucky draw stub(s) and drop it into the lucky draw box provided in any participating FairPrice stores. For FairPrice On customers, lucky draw chance(s) will only be given upon delivery fulfilment, and you are required to drop off the lucky draw stub(s) by 21 Feb 2019 at the nearest participating FairPrice stores in order to be eligible for the draw. All incomplete or illegible entries will be disqualified automatically.

There will be 8 draws, and non-winning entries for each draw will be snowballed into subsequent draws till the end of the promotion.

Q4. What is the prize to be won?

- A4. Mazda CX-3 2.0 (Soul Red Crystal) (8 Weekly Winners)

Q5. Do all purchases count towards my \$30 spend?

- A5. Statutory items (4D, TOTO, Singapore Sweep, FairPrice Gift Vouchers and Gift Cards), cigarettes, prescription and pharmacy-only-medicines **will not constitute** towards the spend of the draw qualification.

Q6. When are the qualifying submission periods for the lucky draw stubs, and when are the dates for the 8 draws?

- A6. 1st draw: 27 Dec 2018 - 2 Jan 2019 (draw held on 11 Jan 2019); 2nd draw: 3 Jan 2019 - 9 Jan 2019 (draw held 18 Jan 2019), 3rd draw: 10 Jan 2019 - 16 Jan 2019 (draw held on 25 Jan 2019), 4th draw: 17 Jan 2019 - 23 Jan 2019 (draw held on 1 Feb 2019), 5th draw: 24 Jan 2019 - 30 Jan 2019 (draw held on 15 Feb 2019), 6th draw: 31 Jan 2019 - 6 Feb 2019 (draw held on 22 Feb 2019), 7th draw: 7 Feb 2019 - 13 Feb 2019 (draw held on 1 Mar 2019), 8th draw: 14 Feb 2019 - 20 Feb 2019 (draw held on 8 Mar 2019).



Q7. How will winners be notified?

A7. Winners will be notified by phone and/or the email address indicated on the lucky draw stub. Winners who cannot be contacted or do not respond within 24 hours from the point of contact via phone and/or email will be disqualified, in which case the reserved winner will be selected.

Q8. How does a winner collect the prize?

A8. Winner is expected to collect the 'winner's letter' at NTUC Fairprice Co-operative Limited No. 1 Joo Koon Circle #13-01 Singapore 629117. A representative from Trans Eurokars Pte Ltd will contact the same winner within 14 calendar days from the published date of the Prize winner in Straits Times and Lianhe Zaobao. Winner must produce NRIC and 'winner's letter' to collect the Prize at Trans Eurokars. From this point forward, Trans Eurokars Pte Ltd will be responsible for all subsequent arrangements in relation to the Prize.

Q9. What does the prize exclude?

A9. COE, Vehicle Emissions Scheme surcharge (if applicable), servicing program, motor vehicle insurance, Road Tax, IU installation, number plates, GST, registration fee and all locally fitted items are not included.

Q10. How is COE bidding handled?

A10. The winner will pay Trans Eurokars Pte Ltd an administrative fee of S\$1,000 to facilitate registration and COE bidding on the winner's behalf. A deposit of S\$10,000 is payable to Trans Eurokars Pte Ltd by the winner to proceed for COE bidding.

Q11. Can I exchange the prize for something else?

A11. Prizes are non-exchangeable for cash and non-transferable.

Q12. What happens to unclaimed prize(s) after 2 months?

A12. Any unclaimed Prize(s) after two (2) months of the announcement of the winner(s) will be donated to charity. NTUC Fairprice Co-operative Limited's decision in relation to the winner shall be final and no correspondence will be entertained.
